NARRATIVE On Tuesday, September 21th, 2021 I was assigned to the Mountainside Police Department's Patrol Division, utilizing semi-marked patrol vehicle #132, and assigned the R1 District. At approximately 15:44 hours, I was dispatched via the Communications Division to Police Headquarters to initiate a Harassment report. Upon my arrival, I encountered a female later to be identified as Ms. Linda Mennella [REDACTED]. Ms. Mennella stated that her niece later to be identified as Ms. Wendy Mitchell ([REDACTED]) of [REDACTED] threatened to drive from her location ([REDACTED]) and kill her. Ms. Mitchell didn't threaten her aunt (Ms. Mennella) directly, she threatened her through her family members who which notified her. Ms. Mannella stated that she does have her niece on a recording but does not have access to the recording at this time. Ms. Mannella states that they have never resided together and she is not currently in immediate fear for her life. Ms. Mannella expressed that Ms. Mitchell is currently on medication for an unknown purpose and does currently psychiatry. Ms. Mitchell hasn't threatened Ms. Mannella in the past and it started about six (6) to eight (8) years ago. Sergeant T. Norton was advised of the incident. Body-worn camera was activated. Ms. Mannella was referred to the Municipal courts.
