**RESOLUTION ACCEPTING BID AND AWARDING CONTRACT TO HART HALSEY LLC
DBA EXTRA DUTY SOLUTIONS FOR THE MANAGEMENT AND ADMINISTRATION OF
THE POLICE OFF DUTY DETAIL**

WHEREAS, in conformance with N.J.S.A 40A:11-4.1 et seq, Resolution R.310-062018 authorized the use of competitive contracting for the Management and Administration of the Edison Police Division's Off-Duty Detail; and

WHEREAS, bids were received by the Township of Edison on July 25, 2018 for RFP No. 18-07-05, Police Off-Duty Detail Management System; and

WHEREAS, after review and evaluation of said bids, it has been recommended by the Evaluation Committee that this contract be awarded to HART HALSEY LLC DBA EXTRA DUTY SOLUTIONS, 101 Merritt Blvd, Suite 21, Trumbull, CT 06611; and

WHEREAS, compensation to HART HALSEY LLC DBA EXTRA DUTY SOLUTIONS for these services shall be from the companies requesting extra duty detail in the form of 7.75 percent on the gross salary; and

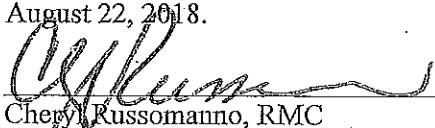
WHEREAS, the initial contract term shall be for two (2) years from execution with three (3), one (1) year renewals at the sole discretion of the Township at the same prices, conditions, requirements and terms of the contract; and

WHEREAS, the Township Council accepts Edison Township's recommendations as described herein and as submitted on the summary spreadsheet.

NOW, THEREFORE, IT IS RESOLVED by the Township Council of the Township of Edison, as follows:

6. All bids have been evaluated and the bid submitted by HART HALSEY LLC DBA EXTRA DUTY SOLUTIONS, 101 Merritt Blvd, Suite 21, Trumbull, CT 06611 for the Edison Police Division's Off Duty Detail Management System has been recommended by the evaluation committee through the competitive contracting process.
7. The Mayor, or his designee, is hereby authorized to execute a contract with HART HALSEY LLC DBA EXTRA DUTY SOLUTIONS for a period of two (2) years with the option of there (3) one year renewals as described herein.
8. Notice of the award shall be published in the official newspaper, as required by law, and shall be on file and available for public inspection in the office of the Edison Township Municipal Clerk.

CONTRACT AGREEMENT

THIS AGREEMENT, authorized by the Municipal Council on August 22, 2018 and effective as of the date signed by the Mayor is between the **TOWNSHIP OF EDISON**, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, party of the first part, and **HART HALSEY LLC D/B/A EXTRA DUTY SOLUTIONS** organized and existing under the laws of the State of Connecticut, duly authorized to conduct business in the State of New Jersey and having it's principal office at 101 Merritt Blvd., Suite 21, Trumbull, CT 06611 party of the second part.

WITNESSETH, that the said party of the second part, for and in consideration of the payments hereinafter specified and agreed to be made by the party of the first part, hereby covenants and agrees to furnish to the Township of Edison under **CONTRACT NO. 18-07-05-POLICE OFF-DUTY MANAGEMENT SYSTEM-** with compensation for these services to HART HALSEY LLC D/B/A EXTRA DUTY SOLUTIONS in the form of 7.75% on the gross salary, as set forth in the Information for Bidders, Proposal, Specifications and Resolution **#R.430-082018** awarding this contract which are hereby made a part of this agreement as fully and with the same effect as if the same had been set forth at length in the body of the agreement, and will furnish said material or service required, **at no change in the unit price bid herein**, upon specified notice at any time during the period ending one year from the date of this Contract. The party of the second part agrees to make payment of all proper charges for materials required as aforementioned, and indemnify and save harmless the party of the first part, it's officers, agents and servants and each and every one of them against and from all suits and costs of every name and description and from all damages to which the said party of the first part may be put by reason to injury to person or property of others resulting from carelessness in the supplying of materials through any improper or defective machinery, implements or appliances used by the said party of the second part in the supply of materials, or through any act or omission of the part of the said party of the second part, or his agent or servant.

It is also agreed and understood that the acceptance of the final payment by the bidder shall be considered as a release in full of all claims against the Township of Edison, in the County of Middlesex, out of or by reason of the materials furnished under this contract.

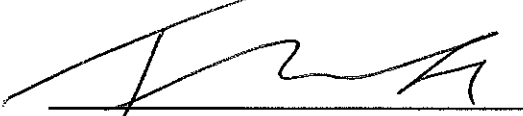
In consideration of the premises the party of the first part hereby agrees to pay the party of the second part for said materials when supplies in accordance with these requirements, for the actual quantity of material furnished under each item scheduled in the proposal, at the respective unit prices bid therefore by the party of the second part, payments to be made within thirty (30) days after completion of the contract if lump sum, or delivery of material and/or services and upon certification of the Director of the Using Department.

IN WITNESS THEREOF: the said party of the first part has caused this instrument to be signed by its Mayor, attested by its Clerk, pursuant to a Resolution of the said party passed for the purpose. The party of the second part has caused this instrument to be signed by its Chairman/Owner/President and attested; has its corporate seal to be hereunto affixed, if applicable.

TERM: This agreement will remain in effect for a period of one (1) year from the date of the contract or until the depletion of the maximum dollar amount allotted for this contract. If the maximum dollar amount is depleted prior to the one year contract term, additional funds may be authorized by the council to complete the one year term of the contract at their discretion, or this contract may be rebid, whichever is in the best interest of the Township.

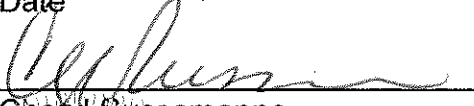

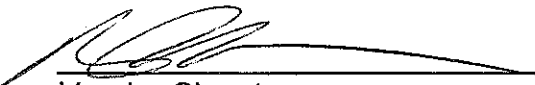
