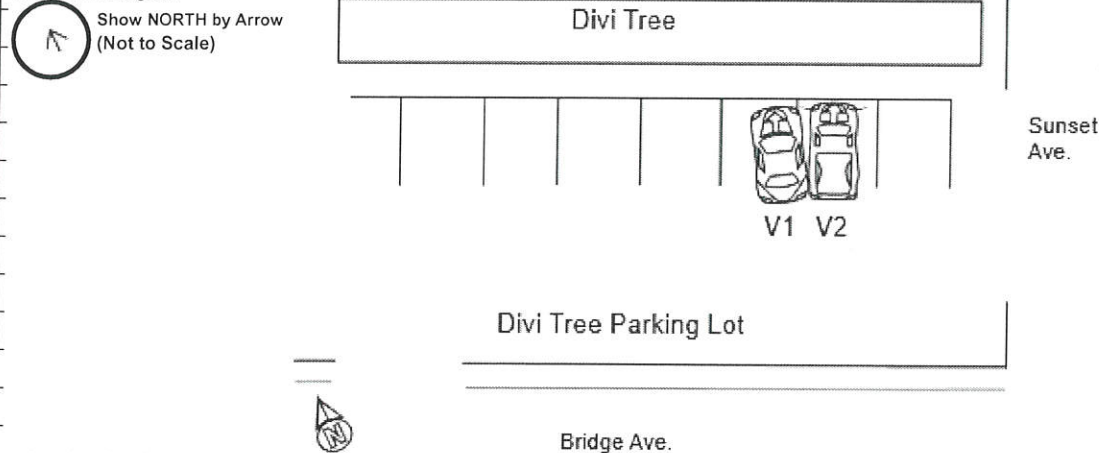

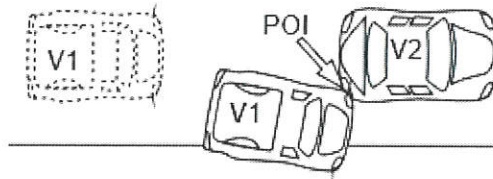

145. Crash Description/Narrative

The driver of vehicle 2, Irene Forrester, stated she was operating north on Arnold Ave when she felt vehicle 1 make contact with the rear of her vehicle.

The driver of vehicle 1, Anthony Dapuzzo, stated he was operating north on Arnold Ave, the radio in his vehicle was not working. He took his eyes off the roadway to fix the radio (Box 118a), looked up, saw vehicle 2 and attempted to swerve out of the way, striking the rear of vehicle 2 (Box 118b).

Upon conclusion of my investigation, vehicle 1 is at fault.

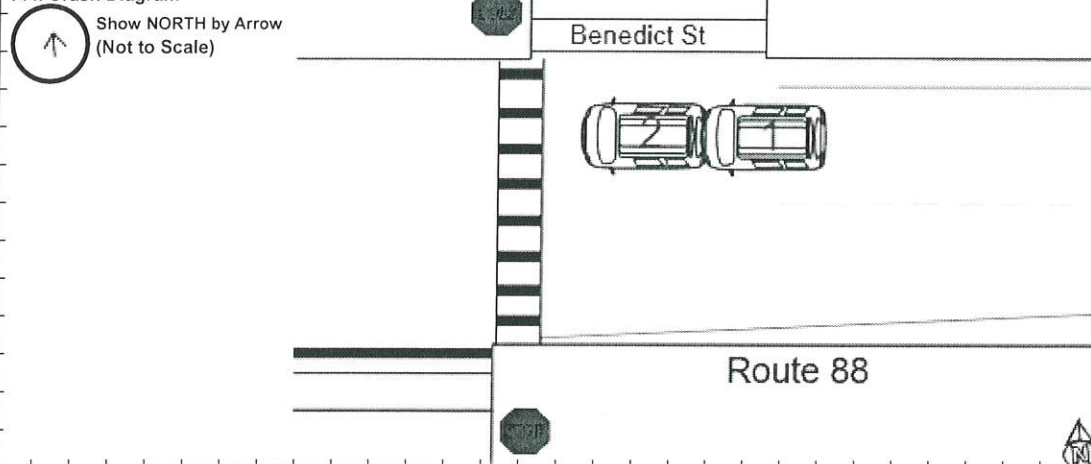

145. Crash Description/Narrative

Driver 2, Ms. Ackermann, stated that she was traveling west on Rt. 88. She observed pedestrians in the crosswalk so she stopped. When she stopped, vehicle 1 collided into the rear of her vehicle.

Driver 1, Ms. Solina, stated that she was traveling west on Rt. 88. She took her eyes off the road to adjust her rear view mirror. When she looked up, vehicle 2 was stopped and she did not have enough time to stop. Her vehicle collided into the rear of vehicle 2.

One of the pedestrians, Mr. Roach, stated that he was crossing Rt 88. An eastbound vehicle stopped so he began to cross. He said that vehicle 2 must have seen him at the last second because vehicle 2 braked rather abruptly. When vehicle 2 stopped, vehicle 1 collided into the rear of vehicle 2.

Based on my investigation, Driver 1, Ms. Solina, is at fault.
