Re: OPRA Request

The following is the Point Pleasant Police Department's response to your OPRA request for certain records:

Request 1: Police dispatch logs of all incidents of police dispatched to the following addresses from 2000-present:

3119 Rt 88
3217 Rt 88
2615 Bridge Ave
654 Ocean Road
655 Ocean Road

Response 1: This request is denied because the request would require the custodian of record to conduct extensive research among its records to ascertain, analyze and compile such information which is not readily available. "OPRA does not require records custodians to conduct research among its records for a requester and correlate data from various government records in the custodian's possession. [citation omitted]." MAG v Division of ABC 357 N.J. Super 534, 546-547 (App. Div. 2005). Furthermore, the request would require the municipality to conduct research and additional work which would substantially disrupt the operations of the government office as prohibited under N.J.S.A. 47:1A-5g. Thus, the information requested is overly burdensome to the municipality. Please advise should you wish to narrow the time frame of your request.

Request 2: Arrest reports/criminal complaints for the borough for the dates 4/10/2009-4/20/2009.

Response 2: Granted. See attached Special Complaint Summonses 1524-SC-007227 and 1524-SC-007527 subject to redaction in accordance with N.J.S.A 47:1A-1.
