Investigation Narrative

On Thursday April 12, 2018 at approximately 1631hrs. Ptl. Rickvalsky and I responded to 1720 Ridgeway Road for the report of a fence on fire. Upon arrival, the fire had been extinguished by the tenant living at the location who was identified as **3** [REDACTED]. We spoke to **4** [REDACTED] and she stated that they were sitting by her outdoor fire pit when another male (she stated the she did not know his name but calls him **5** [REDACTED]) threw a box into the fire which due to the wind blew into the fence causing the fire.

A black Dodge Dakota was observed leaving the scene prior to our arrival with a New Jersey registration **6** [REDACTED], which may have been operated by the male. The fence had two sections completely destroyed and a Honda 400EX ATV near the fence (Engine serial # **7** [REDACTED]) sustained melted plastics and a melted rear driver side tire. Manchester Fire Company and State Forest Fire Brian Corvenus responded to investigate and concluded the story provided by **8** [REDACTED] appeared to be true. **9** [REDACTED] was issued a Township Ordinance for having an open burn and I notified the victim (property owner) identified as **10** [REDACTED] about the incident.
