Summary

Patrol discovered an occupied motor vehicle in the parking lot of Cob Web Corner. A male subject, later identified as Dwight Layton, was sitting in the driver's seat slumped over at the wheel. After denying consent to search the vehicle, a positive K9 indication led to the discovery of heroin, fentanyl, crystal meth, steroids and several prescription legend drugs. Charges were placed on a complaint- summons (S 2021 000120) and Dwight was lodged at ACJF on an NCIC warrant.
