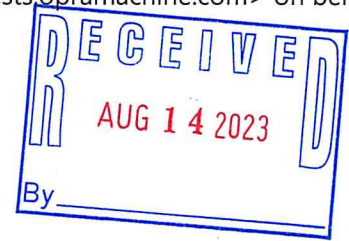

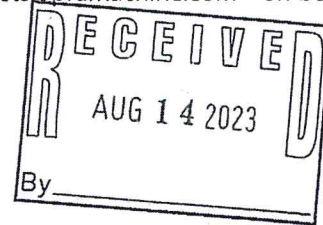

Since then, Murphy shows up to Pellegrino's apartment and knocks on her door while telling her neighbor's that he and Pellegrino are going to get married. Pellegrino stated that Murphy has texted her and called her but her phone had no calls or texts from Murphy. Pellegrino stated she does not know how Murphy obtained her address because she never gave it to him. Murphy most recently showed up at Pellegrino's apartment today at 1530hrs but she did not answer the door. I provided Pellegrino with her options and advised her I would document the incident. I advised Pellegrino to call the Police if he shows up again so we can make contact with him and tell him to stop harassing her.

It should be noted that Pellegrino and Murphy were never involved in a dating relationship and that no threats were ever made.
