She said that they looked at a house in Hopatcong two days ago and Murray put \$650,000.00 dollars down on the house. Pellegrino stated that she told Murray that the house was a bad idea and he did not return the money to her checking account. She then said that this happened 30 minutes ago and that he lived in back of the building in the tunnels. She also stated that he owns a business in the back of the building and then walked out to the first floor lobby and said the business was in the front. Pellegrino told me later in the conversation that Murray was only her boyfriend and she does not know his date of birth, cell phone, what kind of vehicle he drives or where he lives.

I asked Pellegrino if she needed to speak to anyone from the hospital and she said that she was just placed on new medication but does not believe it is working. Pellegrino did not wish to be transported to the NMC. I advised her if she wanted this incident investigated, she has to provide documents, receipts and bank statements. I also advised her that I would be calling her brother and she said that she did not want him contacted. I advised her to call the station if she is able to provide the documents needed to investigate.
