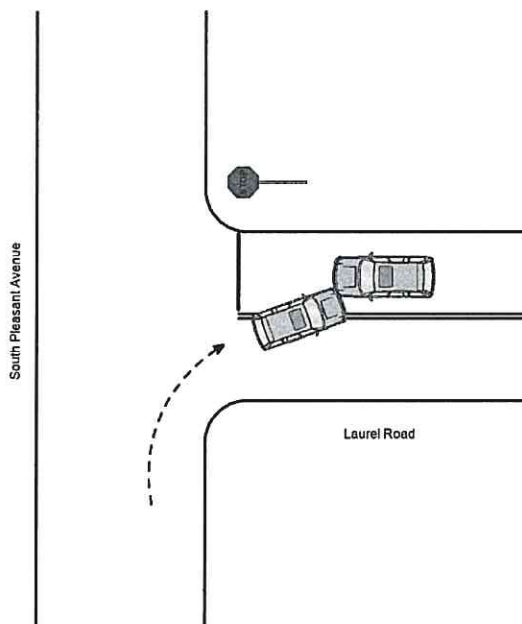

145 Crash Description

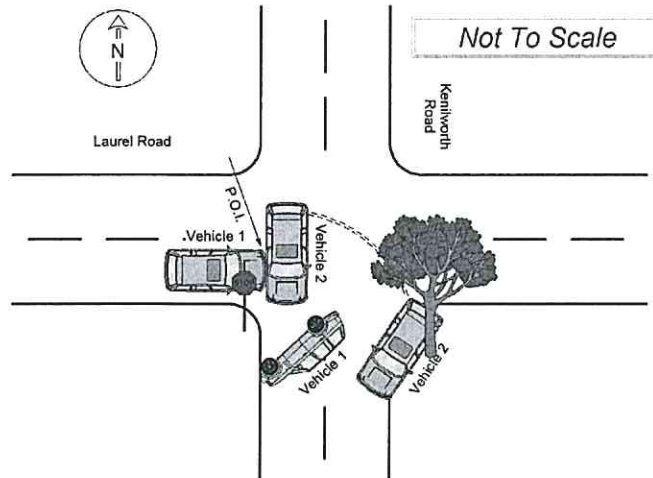
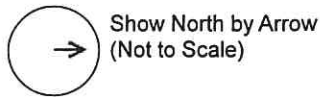
Vehicle 1 was traveling east on Laurel Road approaching South Pleasant Avenue. Vehicle 2 was turning right onto westbound Laurel Road from South Pleasant Avenue. Driver 1 reported vehicle 2 entered her lane of travel while turning and struck her vehicle on the front driver's side. Driver 2 reported as he was turning right onto Laurel Road, his drink spilled onto his lap, causing him to look down. Driver 2 reported he then turned wide onto Laurel Road and into vehicle 1. Driver 1 reported minor chest pain but refused medical attention on scene.

145 Crash Description

Driver of Vehicle 1 stated she was travelling east on Laurel Road. Driver 1 stated she stopped at the stop sign at Kenilworth Road and proceeded into the intersection and collided with Vehicle 2. Driver 2 stated she was travelling south on Kenilworth Rd. Driver 2 stated Vehicle 1 entered the intersection without stopping at the stop sign on Laurel Road at Kenilworth Road, then collided with Vehicle 2 in the front passengers side panel. The impact of the collision caused vehicle 2 to collide with a tree, and Vehicle 1 to overturn. I observed Vehicle 1 overturned on the passengers side door. I observed Vehicle 2 resting on its left side against a tree on the property of 303 Kenilworth Road. Vehicle 1 had damage to the front bumper. Vehicle 2 had damage to the front driver's side door and paneling as well as damage to the driver's side from colliding with the tree. All parties on scene were treated by Ridgewood Fire and EMS. Driver 1 and Andrew Dominguez were transported to Hackensack UMC for treatment. Driver 2, Alyssa Heinis, and Emily Heinis were transported to Valley Hospital for treatment. There were skid marks emanating from the direction of travel of Vehicle 1. I issued Driver 1 a summons 39:4-144 (Failure To Observe Stop Sign). Both vehicles had extensive damage and were towed from the scene via City Wide Towing.

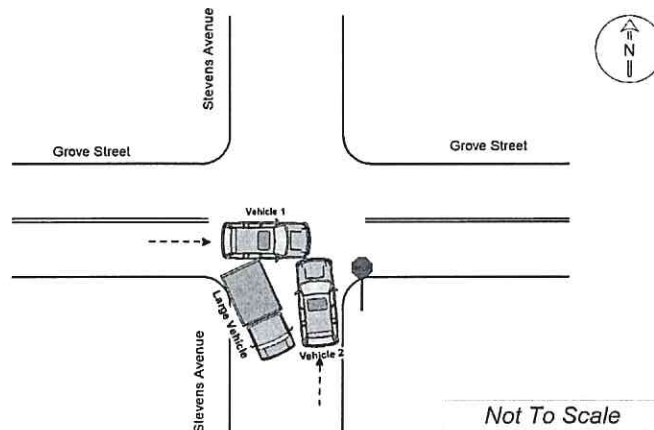

145 Crash Description

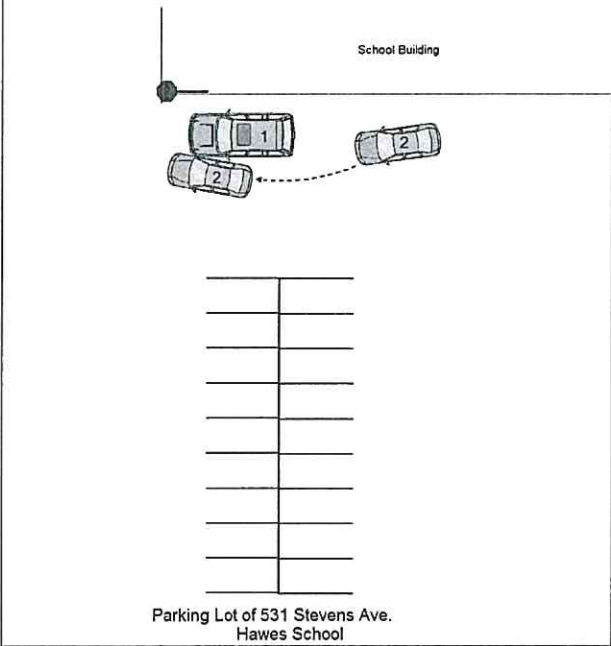
