Upon arrival, I was met by the reporting party and General Contractor of A-Team Concrete (104 George St, South River NJ, 08882), Mr. Robert Abreu (104 George St, South River NJ, 08882 DOB: 09-20-1974, [REDACTED] who stated, when his work crew arrived this morning at approximately 0700 Hrs, they observed what appeared to be telephone wires in the middle of the roadway in front of 717 5th St and 704 5th St Secaucus coming from pole #60231. He informed the Undersigned that his trucks were not the ones who damaged the wires. His work crew was able to move the wires on to the side of the road and both homeowners were notified of the incident.

HQ was advised to contact Verizon and inform them of the incident. Mr. Abreu just wants this incident documented.
