On 11/23/2013 at 3:56 PM, I, PO Phillips, responded to Police Headquarters to document a fraud report from Lauren Fitzpatrick. Ms. Fitzpatrick stated that on 11/18/2013, she had been contacted by a friend of hers, Andrew Debenedictis. Mr. Debenedictis had met with Ms. Fitzpatrick for an unrelated matter. During their time together Mr. Debenedictis asked Ms. Fitzpatrick [REDACTED]
