The request is also for the AC Fire Department run sheet and report of activity, any and all photographs taken at the scene and all video footage obtained on the date of loss, prior to the fire, during the fire, and after the fire from the surveillance cameras located on Hummock Ave.

Records are also requested for all police and or fire department response to 1811-1809 Hummock Ave and or on Hummock Ave in close proximity to 1811-1809 Hummock Ave.

Records are also requested for any and all Code violations at 1811-1809 Hummock Ave.
