On 04/05/2023 I responded to 75 Westover Avenue on a report of fraudulent activity.

Upon arrival, I met with the resident, Nick Cicchino, who reported he is selling a stereo monitor through the website, [REDACTED] for \$2,800.00. On 04/04/2023, he was contacted by a "Tom Kane" [REDACTED], who wished to purchase the monitor. Kane advised Cicchino that he will be sending him a check for \$5,990.00 for the monitor and will have a moving company (NFI) retrieve the monitor during the afternoon of 04/05/2023. Kane directed Cicchino to pay the moving company employees the remainder of the balance for their services, which would be \$3,190.00.

Cicchino reported he agreed to the sale terms and Kane sent him a Metro Credit Union check today for \$5,990.00 via FedEx (sent from 3001 Chamberlain Lane, Louisville, KY). Cicchino reported he then deposited the check into his Chase checking account and the check cleared without incident. Cicchino reported shortly after making the deposit he did not feel comfortable about the amount of money Kane sent him and felt paying the moving company to move the monitor, which does not require more than one person to lift, was suspicious. While speaking with Cicchino he emailed Kane advising that he does not wish to go through with the purchase due to his doubts that the check is not valid and the money may be taken out of his account.

I advised Cicchino to explain this incident to a Chase Bank representative for advice on how to proceed. Cicchino spoke with a Chase representative who advised him that the check is valid, however, the funds can be returned to Kane if he contacts Metro Credit Union and recalls the check. I advised Cicchino that this incident would be documented and to continue to monitor his bank accounts. A picture of the check has been uploaded to the Home folder.

On the above date I responded to 75 Westover Avenue and spoke with CICCHINO regarding a neighbor dispute. CICCHINO stated LEWICKI has been changing the contour of her front lawn which is leading to increased water flow and debris collection at the end of his driveway. CICCHINO stated he has attempted to have conversations with LEWICKI and her husband regarding the matter but has been met with agitated resistance. CICCHINO indicated that he went over to the landscaper working on LEWICKI's property today to explain the issue but was told to leave. I explained that LEWICKI is free to landscape her own property as she sees fit and CICCHINO could not interfere. CICCHINO advised that tensions between he and his neighbors have gotten high because of on-going issues and felt harassed by LEWICKI's husband's aggressive nature towards him. I advised CICCHINO that he has the right to sign complaints through the West Caldwell Municipal Court.

LEWICKI indicated CICCHINO has had a long standing issue with her yard maintenance and would not let her speak with his fiancée, CANDIO-SEKEL, regarding the matter. LEWICKI stated CANDIO-SEKEL is the homeowner and would like to speak with her in an attempt to remedy the issue and does not appreciate CICCHINO on her property, telling her landscaper what to do.

I advised both CICCHINO and LEWICKI that complaints regarding their property issues can be directed to the town for proper guidance.
