Narrative

On December 26, 2016 at approximately 14:30 hours, I responded to 321 2nd Street; 1 in reference to a dispute. I spoke with all parties involved with assistance in translation from Ptl. Hornack #243. Maria Reguera wished to report that Estefani Martinez assaulted her. Ms. Reguera stated that Ms. Martinez grabbed her child in a manner that she did not appreciate in the kitchen, which prompted a physical altercation. Ms. Reguera stated that Ms. Martinez grabbed her by the hair and struck her. I spoke with Gasiel Santiago, Ms. Reguera's husband, who confirmed the allegations. I observed minor scratches sustained to Ms. Reguera's arm.

I then spoke with Estefani Martinez and her mother Claudia Romero. Ms. Martinez stated that she was assaulted by Ms. Reguera as a result of her being mad about her child. Ms. Martinez also sustained minor scratches sustained to her left arm. I then spoke with Ms. Romero, who stated there has been underlying issues in the past in reference to rent and garbage with Ms. Reguera and Mr. Santiago.

All parties involved confirmed that both families rent separate rooms in the household, both of which are separated by closed bedroom doors. Both families are of no relation to each other, and none have been involved in a dating relationship. Both parties involved were not in need of medical attention. Complaint procedures were advised.
