Narrative

On June 18, 2020 at approximately 1542 hours I, Ptl. N. Shimonovich #392, responded to the parking lot next to 321 2nd St in reference to a vehicle burglary involving NJ Reg K39HUU.

Upon arrival I spoke to the caller and the owner of the vehicle, Evelyn Xochicali, who stated that she parked her car here for work at 0900 hours and sometime between then and now someone broke the passenger side rear window to gain entry to the vehicle and stole her Tory Birch purse, black in color and her NJ driver's license.

A surveillance camera was located at 321 2nd St. that points towards the parking lot. I spoke to Dr. Faktor at the "Lakewood Family Dentistry" who stated that he would be able to show us the camera at a later date since he was busy with the patients at the time.

Tools used to break into the vehicle were not found on scene. The window is approximately \$100 to repair and the purse is approximately \$250.
