145. Crash Description/Narrative

On 06/27/2026 at approximately 1702 hours, I responded to a two vehicle MVC at the intersection of Lakehurst Rd, and S. Lakeshore Dr. Upon my arrival, both driver of Vehicle #1 and Vehicle #2 advised of no injuries ,

The driver of V1 advised that she was following behind V2 and thought that V2 was accelerating and when she went to apply the brakes, she collided into the rear of V2. I observed minor damage to the front of V1.

The driver of V2 advised that he was stopped at the stop light facing Southbound on S. Lakeshore Dr, when V1 collided into the rear of V2. I observed moderate damage to the rear of V2. Both vehicles were operable, nothing further at this time.

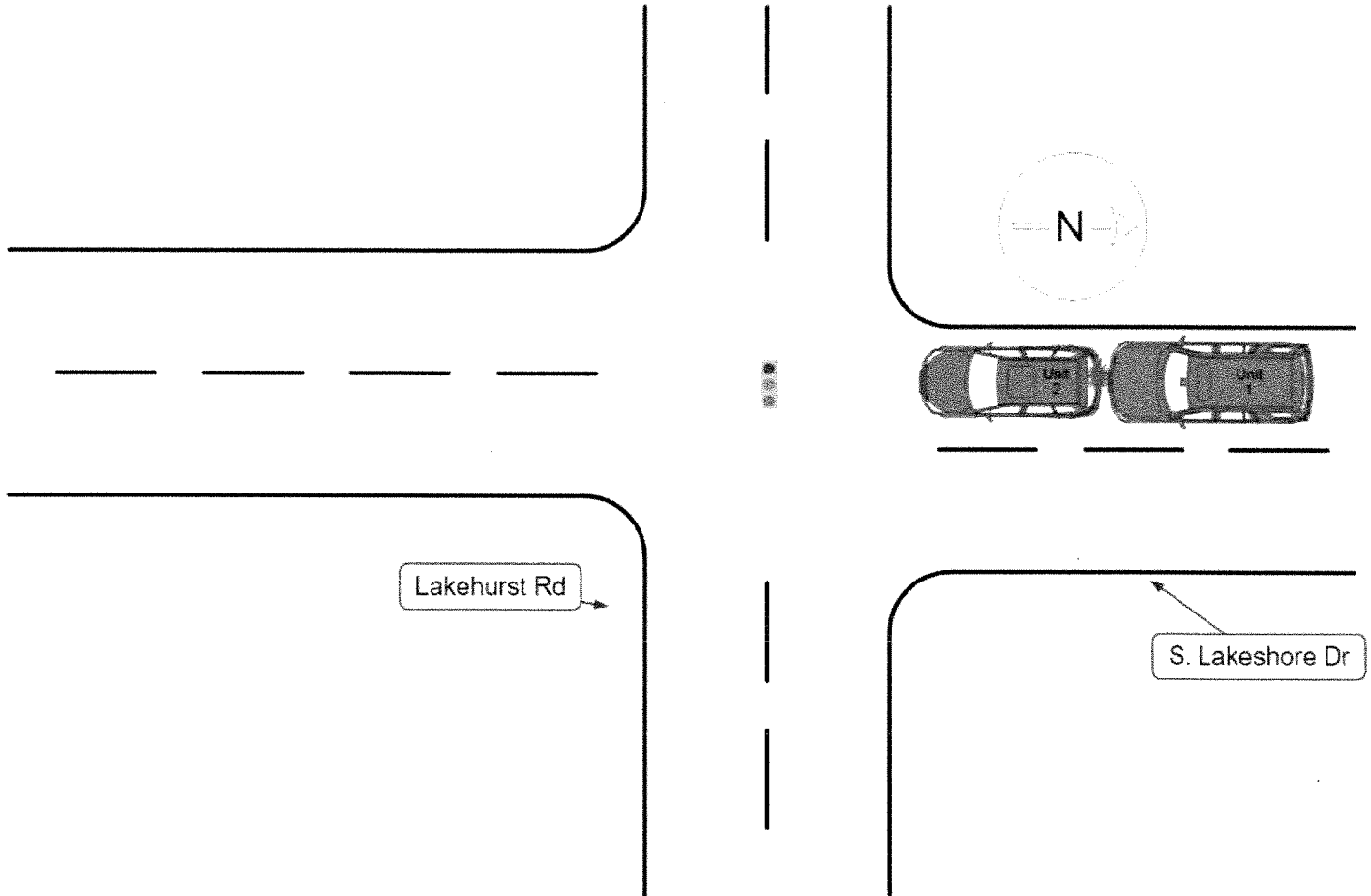
