Nicole advised she made a report in Freehold Borough in 2012, due to John physically grabbing her and punching holes in their residence during an argument. Nicole states that she is worried about how John is going to react when served with divorce papers.

Nicole also stated that there is an old gun in the house that John's mother gave to him. Nicole stated there is no bullets for the weapon however wanted it documented in case anything should ever happen to her. Nicole continued to state that John is verbally abusive towards her.

Nicole stated nothing had occurred physically recently. Nicole also stated she did not wish to file for a temporary restraining order at this time. Nicole filled out an Oceanport Police Information Sheet which was attached to this report.

Once patrols left the residence earlier, Nicole advised that John called her and said "what the fuck was that all about?" Nicole replied by saying "what do you mean what the fuck was that all about?" He said, "two cops in two days?" John later said, "don't worry about me ill be out of the house by tonight" and then hung up.

I advised Nicole that this does not consist of harassment. Nicole advised she only wanted it documented to her prior statements. Nicole then filled out an information statement.

I asked Nicole multiple times if she feared for her safety or wanted to apply for a TRO which she declined all times. I advised Nicole this incident would be documented and told her to call if anymore incidents transpire.

Narrative

On the above date and time, patrols responded to the above location for an unknown situation.

The call came out as might have some issues with her soon to be ex-husband. Upon arrival, the caller, Nicole Johnson was in the street awaiting police arrival. Officer Leimburg and I Officer Gaita spoke to Nicole and asked her what was going on. Nicole stated that her husband John Johnson is harassing her. Note, Nicole and John still live together. I asked Nicole how John was harassing her and she showed me an email from him. The email was a long letter telling Nicole how much he loved her and pleading with her not to leave him. There was only 1 email and at no point was there threats or any type of harassment.

Patrols advised Nicole that due to still living together, it will be hard for both parties to not communicate with each other. At this point, Nicole packed a bag and went to her parents house.

Patrols spoke to John who advised he was just trying to save his marriage. Patrols advised John to be cognizant to Nicole's wishes to be left alone or it could become a harassment or stalking issue.

It should be noted, Nicole did not wish to seek a TRO at this moment.

After Nicole left the residence, patrols cleared with no further action.
