I responded to 92 Roosevelt Avenue in reference to criminal mischief to a vehicle's tires. Upon arrival, I was met by the victim/registered owner, Tara Decrescenzo. Ms. Decrescenzo stated she approached her vehicle to drive to work the morning of September 6, 2016, and observed that her rear passenger tire was completely flat and had a puncture mark on the outer wall of the tire. She subsequently had the tire replaced for approximately \$200.00. The morning of September 10, 2016, she observed that sometime overnight, the tire which she had replaced had again been completely flattened and had a puncture mark on the outer wall of the tire. Upon her father attempting to place the vehicle's spare, which was mounted to the back of the vehicle, she observed that this tire had also been punctured on the outer wall and was not useable.
