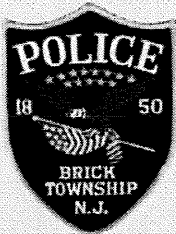

The Traffic Response truck will now be parked in the front row next to the Mobile Command truck. Officers who use this truck should also make sure it is plugged in when they are finished using it.

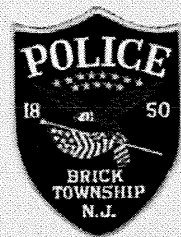
