N.J.S.A. 47:1A-1 provides that "a public agency has a responsibility and an obligation to safeguard from public access a citizen's personal information with which it has been entrusted when disclosure thereof would violate the citizen's reasonable expectation of privacy." N.J.S.A. 47:1A-9.b allows exemptions from disclosure any grant of confidentiality established or recognized by the Constitution of this State, statute, court rule or judicial case law, to apply to OPRA.

Executive Order No. 26 exempts from disclosure "information relating to medical, psychiatric or psychological history, diagnosis treatment or evaluation." See also Rivera v. Town of West New York, GRC Complaint No. 2010-208 (Feb. 2013) (upholding exemption of medical information under Executive Order No. 26)
