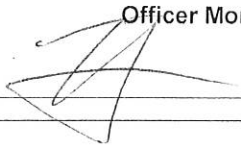

He identified the two subjects later found to be Coleman Light and Sharon Allerdings. Spahr further advised that they were not member of Merri Makers and that they were from Donovan's Reef. The subjects were both laying on lounge chairs on the beach. Light was laying on his side with vomit on his face and on the sand next to him. Allerdings also had some vomit in the area around her chair. Upon request neither of the subjects were able to provide identification. I requested first aid respond to transport both

He was placed in handcuffs for the safty of the First Aid and the officers on scene. Ptl. Bennet responded to assist. First Aid arrived on scene for the transport. Ptl. Bennett and I escorted both subjects to the First Aid ambulance. I rode with the First Aid squad to MMC. Ptl. Bennett gathered up the subjects belongings at Donovan's Reef and returned them to HQ for safe keeping. Both subjects were issued Boro Disorderly Person charges.
