Noemi Mendez called for Police response to 321 2nd St; Apt 1 regarding the theft of baseball equipment that she has previously purchased for her son Brenden Downey. The equipment was contained within a black Worth bat bag and was located, until sometime yesterday, at the entrance to the apartment stairwell. It is believed that Ashley Ferriolo, Downey's ex-girlfriend, took the equipment as she was supposed to come to the apartment yesterday to drop off Downey's Social Security Card that she currently possesses.

Missing at this time is: one (1) black Worth bat bag, one (1) wooden baseball bat, one (1) set of Nike catcher's equipment (color white with navy), one (1) set grey Nike cleats size 10 and teh Social Security card of Brenden Downey. The approximate value of the baseball equipment missing is \$950.

Contact is attempting to be made with Ashley Ferriolo to have her return the property. Mendez stated that she was going to sign criminal complaints against Ferriolo if the property was not returned within the next day or two.
