Investigation Narrative

On February 18, 2017 at 8:31 PM, PO Davison and I responded to 11 Dennison Drive in regards to an escort. The caller reported that her ex-boyfriend was at the front door and requested an officer to respond to ensure there were no issues. Upon arrival, I met with Mr. Leonce Emmanuel who indicated that he arrived at the residence to pick up his clothing to find that the locks on the front door were changed. Mr. Emmanuel stated that he simply wanted to gather some of his belongings and leave the area. When asked, he stated that he has not spoke to his ex-girlfriend, Ms. Marie Rochelin.

I then spoke with Ms. Rochelin who indicated that she has not spoken to Mr. Emmanuel in nearly one (1) month. She stated that after returning home this evening to find that his son's belongings were moved from the residence, she changed the locks. Ms. Rochelin explained that no argument had taken place and she simply contacted this agency to ensure that there would be no issues between them. Mr. Emmanuel gathered some of his belonging before he and Ms. Rochelin made arrangements to meet at 1:00 PM, on February 19, 2017 to gather the remainder of his belongings. Mr. Emmanuel advised that he would contact this agency for an escort.
