On 5/13/21 at 2:27 PM, I, PO Phillips, responded to the Dollar Tree (655 Route 88) after a female called to report that there was another female present who had attempted to assault her. Upon arrival, I spoke with Angela Vacca, who is an employee of the store. She stated that her daughter, Amythist Brito, was the other party involved/victim and had since left the area. Mrs. Vacca called Ms. Brito on her phone at which time I spoke with her.

Ms. Brito stated that she had requested an UBER ride to take her home to Lakewood, NJ. Using the UBER application, the registration and vehicle appeared as required. The driver of the UBER called Ms. Brito and stated that she was upset as she had been waiting for her. Ms. Brito stated that the driver then demanded that she cancel the ride as the driver was not aware that the fare was to Lakewood, NJ. The application advises the driver the end destination and charges the user based on this. Mrs. Vacca stated she was outside and witness to the interaction between Ms. Brito and the driver.

The driver proceeded to say to Ms. Brito that she was going to slap her in the face and demanded she cancel the ride. The driver continued to carry on and then left the area. Ms. Brito stated that she took a photograph of the vehicles registration (GA). I gave Mrs. Vacca a business card so that the picture could be sent to my email. I advised Ms. Brito that I would follow-up with the driver once I have the photograph. I advised Mrs. Brito and Mrs. Vacca that based on the statement that charges would need to be filed by Ms. Brito based on harassment being the charge. I advised Ms. Brito of how to sign the complaints with the court.

As of 5/14/21, I have not received the photograph and needed to leave voice messages for both Mrs. Vacca and Ms. Brito, as neither answered the calls.

On 5/18/21, I received a photo of the vehicle involved via email (GA: RPR7364). The vehicle is owned by PV HOLDINGS CORP or AVIS. The business will only provide information for the renter via a subpoena which will not be granted due to there being no crime involved. I also attempted to call UBER with negative results. They require that the user contact the help line via the application.

I called Ms. Brito and advised her of the above. She was advised to contact me should UBER provide her with any information on the driver. The case is pending this information. A supplemental report will be typed should the driver be identified by UBER.
