Candance explained that for the past two years Monica has said several harmful things about her to neighbors. Candance's neighbors advised her that Monica says that her boyfriend has a criminal history, her children are left home alone throughout the day and her children are bad. Candance also reported that Monica has installed Ring cameras around her apartment and believes she is recording her. To Candance knowledge, Monica hasn't posted any video depicting her in a harmful way. She also added an incident that occurred in the past not reported to police. During that incident, Candance parked her vehicle in the handicap spot and was told to move by management after Monica reported it. When she moved, Monica then parked her vehicle in the spot even though she does not have a handicap permit. For the past two years management has not been helpful in resolving any issues between Monica and Candance. According to Candance, there is a rule signed by the complex that no one can install person cameras on the buildings. I gave Candance several options to correct the issues she addressed. She only wanted to document the incidents at this time.

145. Crash Description/ Narrative

On 24MAY19 at approximately 1754 hours, I was dispatched to 98 Oak St (The Landings at Pine Lake), Lindenwold NJ for a motor vehicle accident that occurred at the 2700 bldg. parking lot.

Vehicle 1 was recently purchased and dropped off by a tow truck to the owner's residence. The owner/driver stated that the vehicle was not fully backed into a parking space. Therefore the owner/driver, Lamar Floyd, knowing the vehicle had brake problems, attempted to back the vehicle in the parking space. However, when placing the vehicle back into the park position, he stated that the vehicle accelerated forward and he was unable to stop due to the brake problems.

Vehicle 1 struck the rear driver side bumper of vehicle 2, pushing it ninety degrees. Vehicle 1 then continued forward and struck the rear driver side bumper of vehicle 3, also pushing it ninety degrees. Vehicle 1 then struck the driver side rear door of vehicle 4 which pushed said vehicle into the driver side rear quarter panel of vehicle 5 which then caused vehicle 5 to strike the rear quarter panel of vehicle 6. Vehicle 1 left a burnout trail of black rubber on the ground from its previous parking place to its final destination; crashed into vehicle 4.

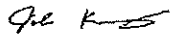
A witness on scene, [REDACTED], confirmed same. She added that she heard the vehicle revving its engine and then she saw white smoke coming from the wheels of said vehicle as it did a burnout and proceeded crashing into said vehicles.

All of the vehicles, with the exception of vehicle 6, were disabled. No airbags were deployed. No injuries were reported.

Vehicles 1-5 were towed from the scene by RHP Towing.

The driver, Lamar Floyd, was issued a summons for driving without a driver's license (39:3-10), unregistered vehicle (39:3-4), driving without insurance (39:6B-2), and careless driving (39:4-97) for knowingly attempting to drive a vehicle with known
