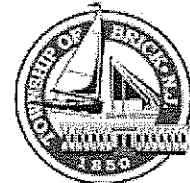

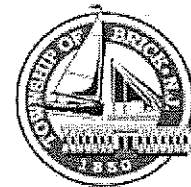

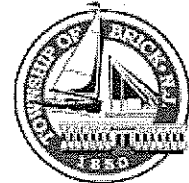
On 01/29/2019 at approximately, 2246 hours, Ptl. Byers #226 responded to a report of a deer struck by a vehicle near the area of Route 70 and Jack Martin Boulevard. The reporting party did not wish to pursue a crash report and the deer was found lying in the roadway. Ptl. Byers advised the watch commander that the deer was incapacitated and unable to walk on its own strength. Sgt. Vendrell #228 then arrived on scene and advised me to respond with a shotgun for the deer to be euthanized.

Upon my arrival, the deer was dragged into the woods away from the roadway and I observed that it was unable to stand. I retrieved the department issued Remington 870 [REDACTED] from patrol vehicle #25 and responded to the area in the woods where the deer was located. I identified the target area of the deer and assured the area behind the deer was clear. I fired one shot into the target area, just behind the fore legs, to impact the heart and lungs, and I observed the deer was still breathing. I fired a second shot in the same area and confirmed that the deer was no longer breathing. The deer was left in the area of the woods and the Department of Transportation was not advised due to the deer being set back away from the roadway.

Additionally, I re-secured the shotgun back in patrol vehicle #25 and responded to Police Headquarters to complete a Firearm Discharge Report.
