145. Crash Description/Narrative

Vehicle 1 was traveling on Jack Martin Blvd approaching the area of the United Medical Park-495 Jack Martin Blvd. Vehicle 2 was stopped in traffic on Jack Martin Blvd waiting to turn left into the United Medical Park-495 Jack Martin Blvd. Vehicle 1 was unable to stop in time and avoid the collision and collided with the rear of vehicle 2.

There were no reported injuries at the scene and both vehicles were towed.

The driver of vehicle 1 stated he was traveling on a Jack Martin Blvd approaching the United Medical Park. He stated he was unable to stop in time and avoid the collision and struck vehicle 2.

The driver of vehicle 2 stated he was stopped in traffic on Jack Martin Blvd waiting to turn left into the United Medical Park, when he was struck from behind by vehicle 1.

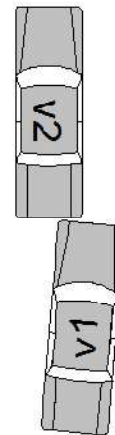
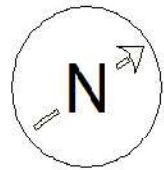
