145. Crash Description/Narrative

Vehicle 2 stopped in traffic, right lane of Rt 70 eastbound just prior to Van Zile Road. Vehicle 1 traveling eastbound in the right lane of Route 70, approaching Van Zile Road.

Driver 2 stated she was stopped in traffic, right lane of Route 70 eastbound, waiting for the red traffic signal to turn green. Driver 2 stated she was stopped for about 30 seconds before she was struck from behind by Vehicle 1. Driver 2 complained of pain to the back of her head and refused any first aid.

Driver 1 stated she was traveling in the right lane of Route 70 eastbound and was not looking at the roadway when she struck the rear of Vehicle 2.

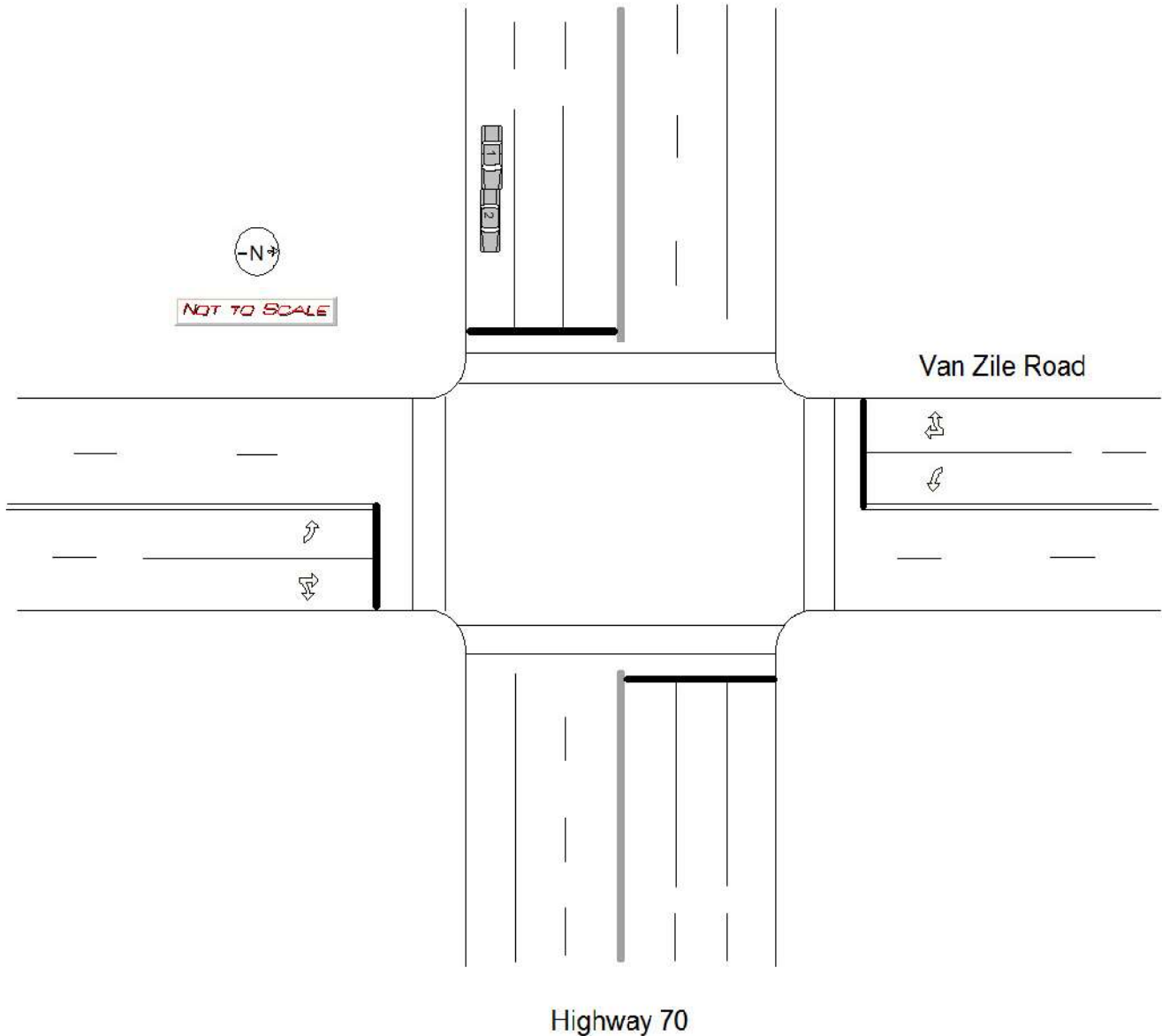
