145. Crash Description/Narrative

Investigation at the scene revealed: Vehicle 2 was traveling east on Rt.70 in the right lane approaching the intersection of Van Zile Rd. Vehicle 1 was traveling east on Rt.70 in the center lane next to vehicle 1. The driver of vehicle 1 did not see vehicle 2 and attempted to change into the right lane approximately 100 feet west of Van Zile Rd. This caused the right middle of vehicle 1 to collide with the left middle of vehicle 2.

The driver of vehicle 1 stated she was traveling on Rt.70 in the center lane and attempted to change into the right lane. Due to a previous accident, vehicle 1 had no passenger side mirror, and opaque plastic covering a broken passenger side window. The driver of vehicle 1 stated she did not see vehicle 2, and changed lanes. This caused the right middle of vehicle 1 to collide with the left middle of vehicle 2.

The driver of vehicle 2 stated she was traveling on Rt.70 in the right lane, when vehicle 1 came into her lane and collided with vehicle 2.

No injuries were reported at this time and both vehicles were moved prior to my arrival.

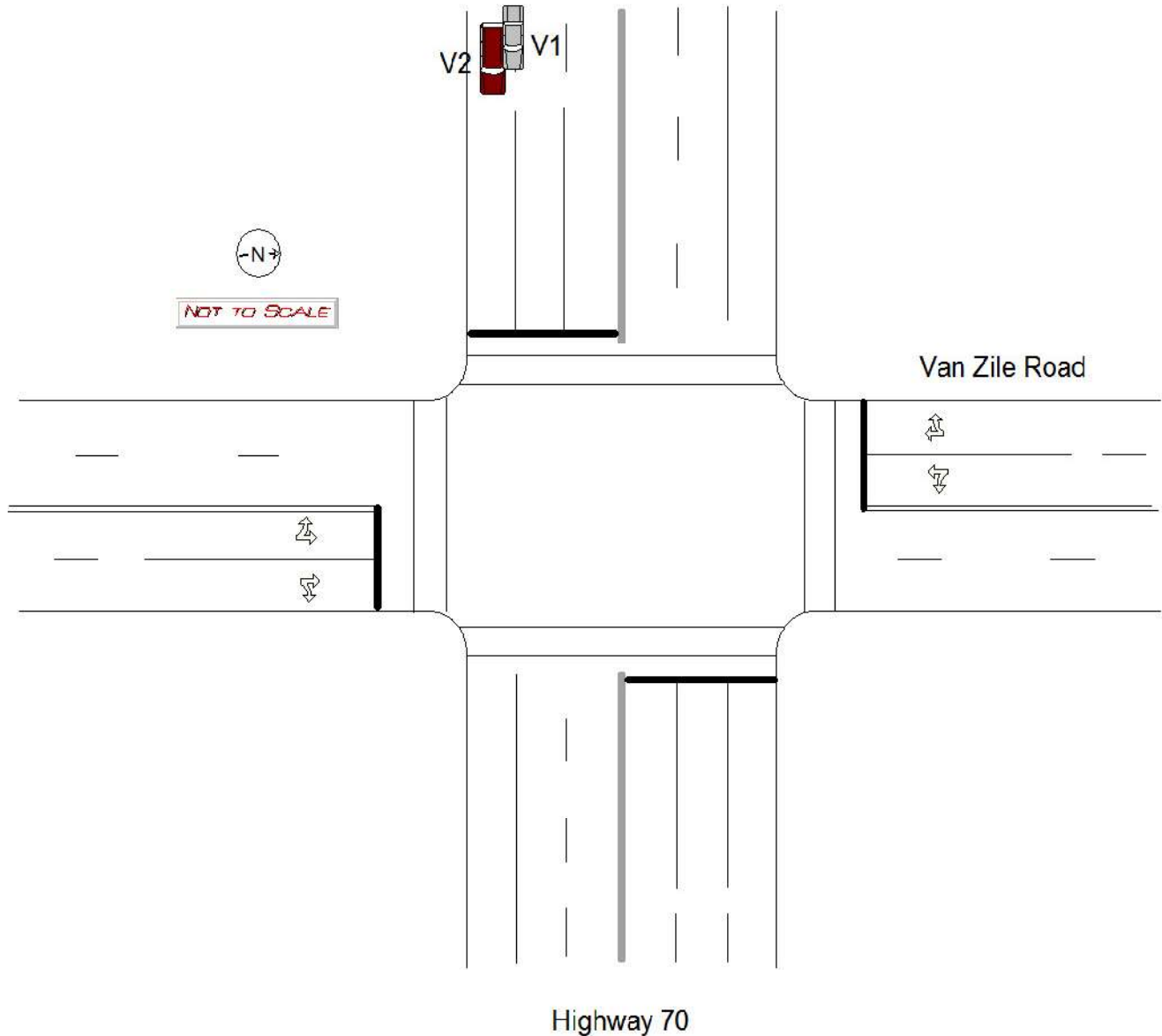
