ON 7/16/2017 I WAS ADVISED BY TELECOMMUNICATOR GROHS THAT HE HAD RECEIVED A PHONE CALL FROM AN "ANONYMOUS" CALLER REQUESTING TO SPEAK TO A CAPTAIN WITHIN THE POLICE DEPARTMENT. GROHS ADVISED THE CALLER THAT THE CAPTAIN WAS NOT ON DUTY TODAY BUT THAT HE COULD SPEAK TO A PATROL OFFICER REGARDING HIS ISSUE. THE MALE DECLINED AND ADVISED GROHS THAT THE MATTER WAS NONE OF HIS BUSINESS. THE PHONE NUMBER WAS DOCUMENTED TO BE [REDACTED] THIS NUMBER WAS FOUND IN CAD TO BELONG TO THOMAS BRUNETTO. THE COMPLAINANT CONTACTED THE POLICE DEPARTMENT ON TWO SEPARATE OCCASIONS WITH THE SAME REQUEST, 1149 HOURS AND 1157 HOURS.

AT APPROXIMATELY 1230 LT. HURTT FROM THE FIRE DEPARTMENT CONTACTED THE POLICE DEPARTMENT TO DOCUMENT A SUSPICIOUS PHONE CALL THEY RECEIVED FROM AN ANONYMOUS CALLER. THE CALLER WISHED TO SPEAK TO THE CHIEF OF THE FIRE DEPARTMENT REGARDING FIREFIGHTER DERRICKSON. THE CALLER KNEW OF DERRICKSONS [REDACTED] AND [REDACTED] AND SUBSEQUENTLY ACCUSED THE FIRE DEPARTMENT OF ATTEMPTING TO SWEEP THE INCIDENTS UNDER THE RUG. LT. HURTT ADVISED THAT MALE THAT HE COULD LEAVE A MESSAGE FOR THE CHIEF HOWEVER THE MALE REFUSED TO PROVIDE HIS PERSONAL INFORMATION. A SHORT PERIOD LATER A MALE WITH A DIFFERENT VOICE CALLED THE FIRE DEPARTMENT, IDENTIFIED HIMSELF AS ONE OF THE THREE SONS. HE STATED HE WASN'T ANONYMOUS AND WOULD RESOLVE THE PROBLEM HIMSELF.

AT THIS TIME LT. HURTT SUBMITTED A WRITTEN STATEMENT REGARDING THE PHONE CALLS THAT TRANSPIRED. GROHS HAD PROVIDED HIS WRITTEN NOTES REGARDING THE CALLS HE RECEIVED.

BOTH CHIEF BENNETT AND CHIEF PLATT WERE NOTIFIED.
