On 2/5/22 at approximately 17:40 hours I, P.O. Barker responded to Stop & Shop for a report of 2 juveniles who had sprayed cherry soda on the caller's vehicle. Once on scene, I spoke with [REDACTED]. [REDACTED] stated approximately 30 minutes prior to calling police, two white juveniles about 12 years of age had been in the Stop & Shop. He believed the 2 individuals had caused damage to some groceries and shoplifted 2 cans of cherry soda.

After [REDACTED] was notified by his employee about the incident, he observed the juveniles in the parking lot of the Stop & Shop Plaza and witnessed them pour what he believed to be soda on his vehicle, NJ:K49FMR which was parked on the east side of the parking lot, near Bridge Ave. The juveniles then left the area, eastbound Bridge Ave.

[REDACTED] believed the damage to his vehicle was strictly coincidence as he did not have any reason to believe 12 year olds would be targeting him. He advised me he would have his Security Dept. attempt to locate surveillance of the incident.
