Vehicle 1 was traveling through the parking lot of 570 Rt 70 when she attempted to make a U-Turn around a parking lot curbed island. Vehicle 1 turned in the lot and approached a stop sign, preparing to turn right and head west in the parking lot. Driver 1 stated she had stopped at the stop sign before turning right. She stated she believed vehicle 2 was speeding as she did not see Vehicle 2 approaching while she checked before turning. Vehicle 1 turned right to head west as Vehicle 2 passed in front of it heading east. Driver 2 stated it appeared that vehicle 1 ran the stop sign. The front bumper of vehicle 1 struck the rear driver side tire of vehicle 2. The bumper of vehicle 1 was removed due to the collision. The rear tire of vehicle 2 appeared to have been punctured by debris from the collision.

Upon my arrival to the scene, vehicle 1 had not moved from the location of the collision. It appeared vehicle 1 took the right hand turn too wide, traveling into vehicle 2's lane of travel as it passed, causing the collision.

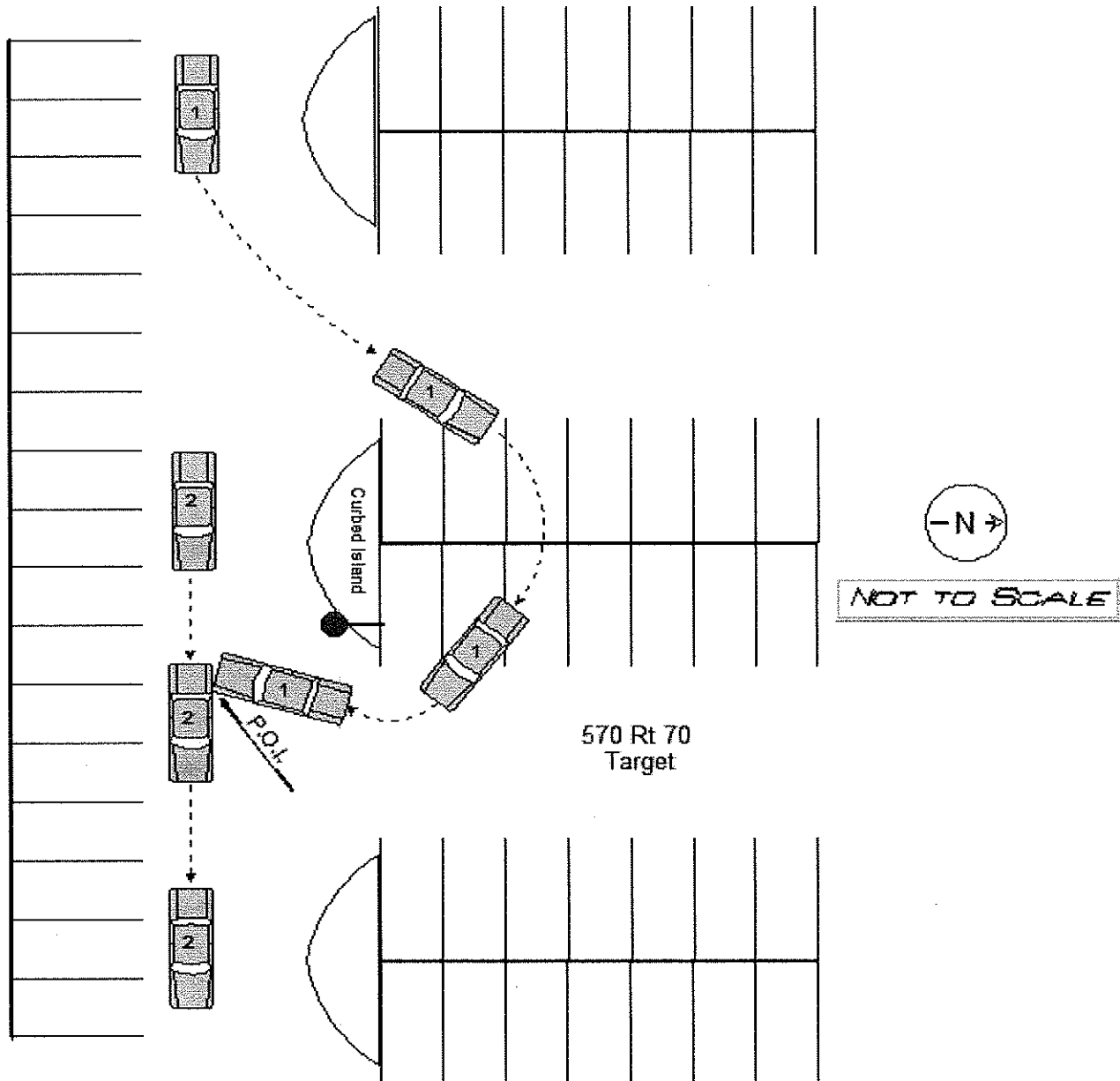

145. Crash Description/Narrative

Vehicle 1 was pulling through the parking lot in the area of 140 Creek Rd. Vehicle 2 was parked and unoccupied directly in front of 140 Creek Rd. At some point as vehicle 1 was traveling through the lot, the driver of vehicle 1 passed out and fell asleep at the wheel. Vehicle 1 then began to roll backwards and collided with vehicle 2.

There were no reported injuries at the scene, there was minor damage to the right lower rear of vehicle 1 and the left lower rear of vehicle 2. The owner of vehicle 2 was contacted and advised of the collision.

Upon arrival to the scene, we observed a white Ford Crown Vic (V1) backed up into a Black Nissan Murano (V2). Ptl. Geskey #184 and I then found the driver of vehicle 1, identified as Alexa Cook to be unresponsive in the drivers seat with the engine running. We were able to wake up Cook, who was very confused and disoriented and did not initially know where she was or that she got into a vehicle crash. We initially checked Cook for any injuries to herself, to which she stated she was not hurt or injured. Brick EMS responded to the scene but Cook refused treatment. Cook stated that she was just returning home from working all night and hadn't slept in a while and must have fell asleep at the wheel. While checking for the registration and insurance documents I

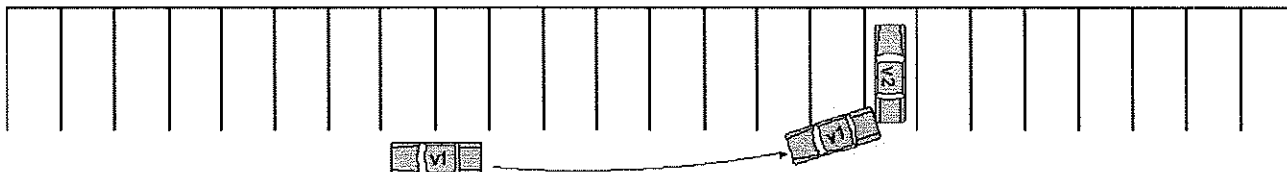

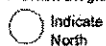

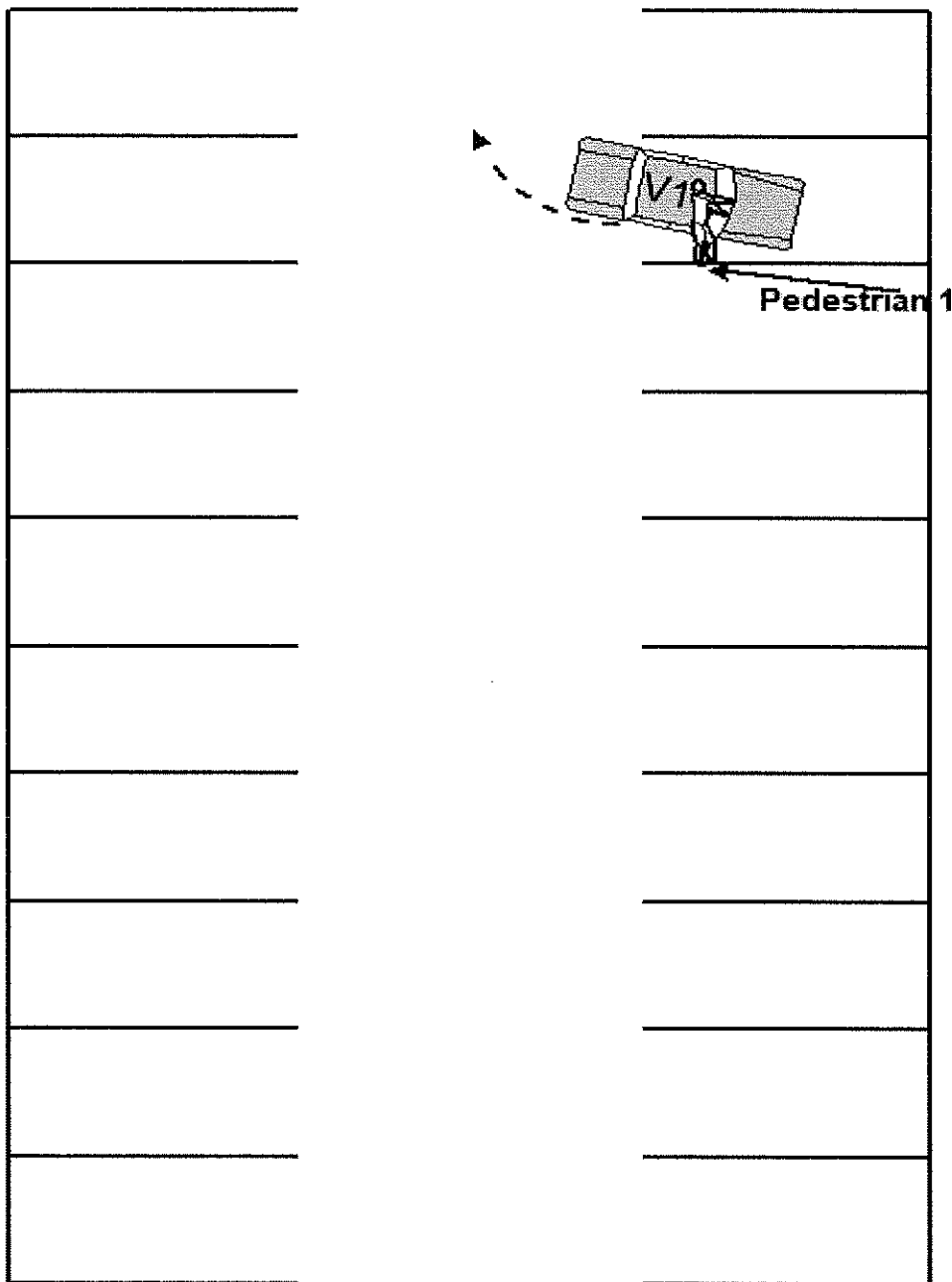
