*****BODY WORN CAMERA #18 WAS VIEWED PRIOR TO WRITING THIS SUPPLEMENTAL REPORT*****

ON 08/28/22 AT 0122 HOURS I, PTL. HERSHEY, WAS RESPONDING TO A FIGHT THAT WAS CALLED OUT IN THE AREA OF SUMNER AVENUE AND BOULEVARD BY A PARKING ENFORCEMENT OFFICER. UPON ARRIVAL, I EXITED MY VEHICLE AT THE INTERSECTION OF SUMNER AVENUE AND BOULEVARD. I WAS INFORMED BY SOMEONE THAT A FEMALE, LATER IDENTIFIED AS [REDACTED] WAS ASSAULTED BY A MALE, AND HE POINTED TOWARDS PARKING ENFORCEMENT SUPERVISOR TIMOTHY FARRELL. I OBSERVED ONE MALE, LATER IDENTIFIED AS MR. DOUGLAS J. PETTY, ON TOP OF ANOTHER MALE, [REDACTED] AND PARKING ENFORCEMENT SUPERVISOR TIMOTHY FARRELL WAS ATTEMPTING TO PLACE HANDCUFFS ON MR. PETTY TO DETAIN HIM. AS I GOT CLOSER, I NOTICED THAT HE HAD HIS RIGHT WRIST IN A HANDCUFF. I IMMEDIATELY TOOK OVER THE SCENE AND USED A SECOND HANDCUFF DUE TO MR. PETTY'S SIZE TO PROPERLY SECURE HIM IN HANDCUFFS.

#1 ONCE PLACED IN HANDCUFFS I STOOD MR. PETTY UP AND INFORMED HIM HE WAS UNDER ARREST FOR ASSAULTING [REDACTED] HE WAS WALKED TO A PATROL VEHICLE AND SEARCHED BEFORE BEING PLACED IN THE REAR OF THE VEHICLE. MR. PETTY WAS THEN TRANSPORTED TO HEADQUARTERS WHERE HE WAS BOOKED AND PROCESSED. I THEN WENT BACK TO THE AREA OF ARREST AND SPOKE WITH PARKING ENFORCEMENT SUPERVISOR FARRELL WHO RELAYED THAT HE SAW MR. PETTY STRIKE [REDACTED] WITH A CLOSED FIST TO THE HEAD RESULTING IN HER FALLING TO THE GROUND. HE ALSO SAID ANOTHER MALE, IDENTIFIED AS [REDACTED] CONFRONTED MR. PETTY ABOUT THE ASSAULT AND THEN MR. PETTY TRIED TO FIGHT HIM ALSO WHICH RESULTED IN THEM ENDING UP ON THE GROUND AS PREVIOUSLY DESCRIBED.

#2 WHILE SPEAKING WITH [REDACTED] ANOTHER WITNESS, IDENTIFIED AS [REDACTED] WALKED OVER AND EXPLAINED WHAT HAD OCCURED. HE STATED [REDACTED] WAS ON THE PHONE AND MR. PETTY JUST WALKED TOWARDS HE AND STRUCK HER WITH A CLOSED FIST TO HER HEAD RESULTING IN HER FALLING TO THE GROUND. HE ALSO SAID [REDACTED] WAS TRYING TO COME TO THE AID OF [REDACTED] AND CONFRONTED MR. PETTY. HE STATED MR. PETTY TRIED TO FIGHT HIM AND THEY ENDED UP IN A SCUFFLE ON THE GROUND. [REDACTED] WERE INDEPENDANT OF EACH OTHER AND WENT THEIR SEPARATE WAYS. BOTH WITNESSES WILLINGLY GAVE THEIR IDENTIFICATION AND INFORMATION BUT WISHED TO REMAIN ANONYMOUS.

I THEN WENT BACK TO MY VEHICLE AND SGT. BRAD FRANK FROM THE OCEAN COUNTY PROSECUTORS OFFICE ASSISTED ME IN COMPLETED A NEW JERSEY VICTIM NOTIFICATION FORM. I THEN SPOKE WITH [REDACTED] AND SHE STATED SHE DID NOT REMEMBER ANYTHING AT ALL. I ADVISED HER OF HER DOMESTIC VIOLENCE RIGHTS BUT SHE DID NOT WANT TO SIGN THE VICTIM NOTIFICATION FORM BUT WAS GIVEN A COPY LISTING ALL OF HER RIGHTS AS A DOMESTIC VIOLENCE VICTIM IN THE STATE OF NEW JERSEY. AFTER COMPLETING MY CONVERSATION WITH [REDACTED] I SPOKE WITH A FRIEND OF HERS WHO STATED THAT THIS WASN'T THE FIRST TIME INDICATING THAT THERE WAS SOME SORT OF ONGOING DOMESTIC VIOLENCE ISSUE BETWEEN BOTH PARTIES.

I THEN RETURNED TO HEADQUARTERS WHILE OTHER OFFICERS WERE COMPLETING THE BOOKING PROCESS. MR. PETTY WAS SAYING HE HAD LOST HIS PHONE. I LOOKED AT THE PROPERTY SHEET THAT WAS COMPLETED AND CONFIRMED WITH OFFICERS THAT HE DID NOT HAVE AN IPHONE ON HIS PERSON. I ADVISED HIM THAT HE MUST HAVE LOST IT PRIOR TO HIS ARREST. I ALSO INFORMED HIM THAT I WOULD ADD THE LOST PROPERTY TO THE REPORT WHICH CONSISTED OF A BLACK IPHONE 13 (\$1,000) AND A BLACK IPHONE CASE (\$100). MR. PETTY WAS UNCOOPERATIVE DURING THE PROCESS ARGUING THAT HE BACKED THE BLUE AND HAD FRIENDS AND FAMILY IN LAW ENFORCEMENT. HE ALSO STATED HE KNEW SENATORS. MR. PETTY HAD AN ABRASION ON HIS ELBOW SO TRI-BORO WAS DISPATCHED TO OUR BOOKING ROOM AND TREATED THE INJURY. THE ABRASION HAD OCCURED FROM THE SCUFFLE WITH [REDACTED] PRIOR TO HIS ARREST. MR. PETTY SIGNED OFF STATING HE DID NOT WISH TO HAVE ANY FURTHER MEDICAL TREATMENT.

AT SOME POINT MR. PETTY STATED HIS KIDS WERE ALONE AND HE NEEDED TO ATTEND TO THEM. AN OFFICER RELAYED THIS INFORMATION AND I IMMEDIATELY CONTACTED [REDACTED] REGARDING THE HEALTH AND WELFARE OF THE TWO CHILDREN. SHE CONFIRMED THAT THEY WERE FINE AND WERE STAYING OVER FRIENDS HOUSES LOCATED IN LAVALLETTE AND MORRISTOWN. ONCE THE BOOKING PROCESS WAS COMPLETE

MR. PETTY WAS TRANSPORTED TO OCEAN COUNTY JAIL BUT THEY REFUSED TO ACCEPT HIM BECAUSE THEY BELIEVED HE HAD A FOREIGN OBJECT (POSSIBLY GLASS) LODGED IN THE ABRASION ON HIS ELBOW. HE WAS THEN TRANSPORTED TO COMMUNITY MEDICAL CENTER FOR FURTHER MEDICAL TREATMENT. ONCE CLEARED MEDICALLY HE WAS THEN TRANSPORTED BACK TO OCEAN COUNTY JAIL AND LODGED ON THE CHARGE OF SIMPLE ASSAULT UNDER DOMESTIC VIOLENCE.

On 08/08/22 AT 0122 HOURS I, SLEO I PARKING ENFORCEMENT SUPERVISOR TIMOTHY FARRELL, WAS PARKED AT 520 BOULAVARD IN THE PARKING LOT FACING NORTH. I WAS IN A MARKED FORD F 150 POLICE PICKUP. I HEARD A MALE YELLING IN A WOMENS FACE REPEATING "LETS GO...ARE YOU FUCKING KIDDING ME". THE MALE APPEARED TO BE INTOXICATED.

I THEN OBSERVED A WHITE MALE, THROW A PUNCH (CLOSED FIST) AND STRIKE A FEMALE IN HER FOREHEAD. THE MALE WAS LATER IDENTIFIED AS DOUGLAS PETTY. I INFORMED COUNTY DISPATCH THAT THERE WAS A DISTURBANCE AT SUMNER AVENUE AND THE BOULEVARD. I EXITED MY VEHICLE AND APPROACHED THE AREA, AND A SMALL CROWD BEGAN TO FORM. I QUICKLY CHECKED ON THE FEMALE VICTIM. SHE WAS VISIBLY HURT HOLDING HER HEAD AND CRYING. I THEN SAW PETTY WALKING NORTH TOWARD HEMINGWAYS. TWO MEN STANDING IN THE AREA YELLED AT PETTY "THATS A FUCKING WOMAN. WHATS WRONG WITH YOU. FUCKING ASS HOLE". AT THAT TIME PETTY GRABBED ONE OF THE MALES AND WRESTLED HIM TO THE GROUND YELLING "THATS MY FUCKING WIFE". PETTY WAS ON TOP OF THE MALE TURNING AND FLAILING. I COMMANDED PETTY TO STOP FIGHTING DURING THE STRUGGLE, I GRABBED PETTY'S RIGHT ARM AND THEN PLACED ONE HANDCUFF ON, AT THAT TIME PATROLMEN ERIK HERSHEY ARRIVED AND HELPED SECURE THE HANDCUFFS.

PETTY WAS ESCORTED TO HIS FEET AND PLACED INTO THE BACK SEAT OF A PATROL CAR FOR TRANSPORT.
