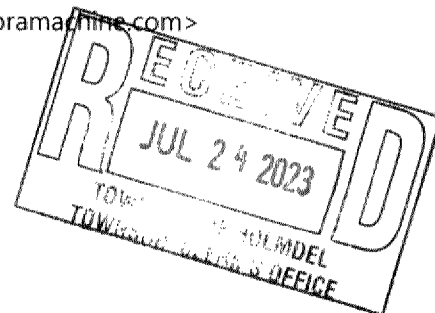

ARREST DESCRIPTION

DUI arrest.

On Friday, 7/22/2022 at approximately 0230 hours while on patrol in marked K9 vehicle 1827. I was equipped with body worn camera #50 when I observed a vehicle parked in the Satz School parking lot. The vehicle in question was a black Ford pickup truck. The vehicle was parked on a diagonal taking up two spaces in the lot. I approached the vehicle, I made contact with a male who was later identified as Jason Cochran. I immediately detected the odor of alcoholic beverages emanating from the vehicle. Cochran was sitting in the driver's seat of the vehicle shirtless and the keys to the vehicle in the ignition. I observed an open Miller Lite alcoholic beer in a cup holder of the vehicle. Cochran's eyes were blood shot red and watery with droopy eyelids. I asked Cochran where he was coming from and stated a concert at PNC Arts Center. Cochran stated that he was waiting for AAA because he was having car trouble. When I asked Cochran how long he has been in the parking lot of the Satz school. Cochran said that he had arrived there approximately an hour and a half after the concert because he was having vehicle trouble. I was having trouble understanding Cochran because he seemed to be talking in circles and did not appear to be coherent. His speech was also slurred as he rambled on about his vehicle. Cochran later admitted to driving his vehicle to the Staz lot from the Arts Center. It should be noted that I checked on a suspicious vehicle in the Satz parking lot at approximately 2305 hours (22-12775) and Cochran nor his vehicle was there at that time.

Based on my suspicion of Cochran operating the vehicle under the influence, I ordered him out of the vehicle so that standard field sobriety tests could be conducted. After Cochran exited the vehicle, I took notice to the front of his pants where he had urinated himself. I directed Cochran over to an area that was level, had adequate lighting and was free of debris in order to conduct the tests. Cochran was unsteady on his feet appearing having a hard time walking as he staggered to where I directed him in the parking lot. After having Cochran face me so that I could start the instructional portion, I detected the odor of alcoholic beverages coming from his person. Ultimately, Cochran stated that he was not going to perform the standard field sobriety tests. Based on my training and experience, I deemed Cochran to be under the influence of alcohol with the intent to drive his vehicle. I Informed Cochran that he was going to be placed under arrest for DUI. I instructed him to turn around. As Cochran turned around, he backed into me almost falling over enough to where I had to hold him up to regain his balance. He was handcuffed where they were checked for proper fitting and double locked. Cochran was secured in the rear of a patrol vehicle where he was then transported to police headquarters by Ptl. Sasso #93. Ptl. Enzerillo #107 remained with the vehicle until the tow company arrived for the impound removal. I also responded to headquarters to process Cochran. The vehicle was later towed to and secured at the impound lot.

Once at headquarters, Cochran was secured in the DUI room where I advised him of Miranda Warning. Cochran stated that he would like an attorney and that he was not answering any questions. Cochran refused to acknowledge the Miranda Warning document. I then read the NJ Attorney General Standard Statement for Motor Vehicle Operators to Cochran. Cochran requested that I read it to him again, which I did. Cochran then stated that he was not going to provide samples of his breath for testing. After being processed, Cochran was later released to Nicholas Derasmo after Derasmo read and signed the Potential Liability Warning. Cochran was issued multiple motor vehicle summons with the appearance court date of 8/10/2022. The three open containers in the vehicle were poured out and

photographed as evidence with shift camera #3 and then disposed of. Det. Hernando was notified via e-mail about the photos. Nothing further to report at this time.
