On 3/14/2023 I was dispatched to Walmart 2291 North 2nd Street for suspicious circumstances.

Upon arrival I met with the caller Miguel Gonzalez, he stated that he made a purchase but did not get a receipt. He claimed while exiting the store an employee identified as Lisa asked for his receipt and forcefully took the item he purchased out of his hands when he could not provide it. He stated that she claimed he was stealing and went to the customer service area when she told other employee and customers he stole the item.

I then spoke to the manager Sierra Bush, she stated she did not witness the incident and was called afterwards. She did advise that Gonzalez did purchase the item and it was returned to him. Another employee identified as Crystal advised of the same.

Gonzalez was advised of his options and I cleared the area without incident.
