intoxicated. The driver of the vehicle was later identified as Alexandra Alanis Ramirez.

Alanis was in the back of the Exceptional Medical Transportations (EMT) vehicle when I arrived on scene. I then observed the crash scene as well as captured pictures. It was determined that no other vehicles or pedestrians were struck in reference to this motor vehicle accident.

It was then explained to me from Sergeant D. Baakoo the actions of the driver in reference to her being possibly intoxicated. Alanis was then placed into custody for 39:4-50 Suspicion of driving while intoxicated as well as 39:4-96 reckless driving. She was then taken down the Atlantic Care Medical Facility to be treated for her injuries in reference to the accident. While inside of the hospital the victim was read her Miranda Rights and refused to answer any questions and refused to give any blood or urine.

Upon further investigation in reference to this case due to lack of evidence the tickets issued in this case are going to be dismissed.
