Driver 3 stated she was travelling southbound on W. Seventh St. and was stopped in traffic waiting for the traffic signal at the intersection of W. Seventh St. and Walnut St. when she heard rapid acceleration approaching from the rear. Vehicle 3 was struck by Vehicle 1 shortly afterward.
