VEHICLE 1 WAS TRAVELLING EAST BOUND ON WASHINGTON AVE AND ATTEMPTED TO MAKE A LEFT TURN ONTO NORTH BOUND PASCACK RD. VEHICLE 2 WAS TRAVELING WEST BOUND GOING STRAIGHT WITH THE RIGHT OF WAY AND COLLIDED WITH VEHICLE 1. OPERATORS OF BOTH VEHICLES STATED THAT THE TRAFFIC SIGNAL WAS GREEN.
