BY TAKING HER CELL PHONE BY FORCE NOT ALLOWING HER TO CALL 911 FOR THE POLICE TO ASSIST.

WITHIN THE JURISDICTION OF THIS COURT, WAGNER YAGCHIREMA-VILLARES DID COMMIT THE OFFENSE OF ENDANGERING THE WELFARE OF A CHILD SPECIFICALLY BY CAUSING HARM TO V2, [REDACTED] WITH CLOSED FISTS WHILE SHE WAS SITTING IN V1'S LAP IN HER VEHICLE AS HE ALSO STRUCK V1.

WITHIN THE JURISDICTION OF THIS COURT, WAGNER YAGCHIREMA-VILLARES DID COMMIT THE OFFENSE OF CRIMINAL RESTRAINT BY RESTRAINING V1 UNLAWFULLY IN CIRCUMSTANCES EXPOSING HER TO RISK OF SERIOUS BODILY INJURY, SPECIFICALLY BY PULLING HER BACK INTO THE VEHICLE WHEN SHE TRIED TO EXIT AND BY TAKING OFF AT A HIGH RATE OF SPEED WITH THE PASSENGER DOOR OPEN.

WITHIN THE JURISDICTION OF THIS COURT, WAGNER YAGCHIREMA-VILLARES DID COMMIT THE OFFENSE OF THEFT SPECIFICALLY BY UNLAWFULLY TAKING V1'S IPHONE 13 PRO MAX FROM HER VALUED AT \$1,099 DURING A DV ASSAULT.

WITHIN THE JURISDICTION OF THIS COURT, WITHIN THE JURISDICTION OF THIS COURT, WAGNER YAGCHIREMA-VILLARES DID COMMIT THE OFFENSE OF SIMPLE ASSAULT SPECIFICALLY BY STRIKING V2 IN THE HEAD MULTIPLE TIMES WITH CLOSED FISTS.

WITHIN THE JURISDICTION OF THIS COURT, WAGNER YAGCHIREMA-VILLARES DID COMMIT THE OFFENSE OF SIMPLE ASSAULT SPECIFICALLY BY PURPOSELY AND KNOWINGLY CAUSING BODILY INJURY TO V1 BY STRIKING HER IN THE HEAD AND FACE WITH CLOSED FISTS MULTIPLE TIMES CAUSING VISIBLE SIGNS OF INJURY.
