ON 03/19/2025 AT APPROXIMATELY 2032 HOURS WHILE ON ROUTINE (UNIFORMED PATROL) I OBSERVED A BLACK NISSAN ROGUE TRAVELING NORTH ON STEVENS AVENUE WITHOUT HEADLIGHTS ON. AS I PULLED BEHIND THE SUSPECT VEHICLE, I ALSO OBSERVED THAT THE LEFT REAR TAIL-LIGHT WAS INOPERABLE. I INITIATED A MOTOR VEHICLE STOP ON THE VEHICLE BEARING NJ REGISTRATION T74SMP IN THE AREA OF STEVENS AVENUE AND SECOND STREET. UPON MAKING CONTACT WITH THE OPERATOR OF THE VEHICLE (LATER IDENTIFIED AS JOSEPH D STAULO III), I IDENTIFIED MYSELF AND REQUESTED FROM STAULO TO PROVIDE ME WITH HIS DRIVERS LICENSE, REGISTRATION, AND PROOF OF INSURANCE. STAULO DEMANDED THAT I INFORM HIM OF THE REASON FOR THE MOTOR VEHICLE STOP BEFORE PROVIDING ME ANY DOCUMENTATION. I INFORMED STAULO THAT I WOULD EXPLAIN THE REASON FOR THE STOP AFTER I HAD HIS DOCUMENTATION. STAULO REFUSED TO PROVIDE ME WITH ANY DOCUMENTATION AND REQUESTED TO SPEAK WITH A SUPERVISOR. DURING THIS PERIOD OF TIME SGT MILLER WAS OPERATING THE DISPATCH DESK AND WAS UNABLE TO RESPOND TO THE AREA. PTL GASIEWSKI WAS THE SENIOR OFFICER ON SCENE AND WAS UNABLE TO SATISFY STAULO'S REQUEST. SGT MILLER REQUESTED THAT PTL GASIEWSKI REPORT BACK TO HEADQUARTERS TO OPERATE THE DISPATCH DESK SO THAT HE COULD RESPOND TO THE REQUEST FOR SUPERVISOR ON THE MOTOR VEHICLE STOP. SGT MILLER WAS UNABLE TO COMPEL ANY IDENTIFICATION OR DOCUMENTATION FROM STAULO. AFTER APPROXIMATELY THIRTY MINUTES STAULO PROVIDED SGT MILLER WITH HIS FIRST AND LAST NAME BUT REFUSED TO PROVIDE A DATE OF BIRTH OR CONFIRM WHETHER OR NOT HE WAS A JR. OR III. AFTER EXHAUSTING ALL EFFORTS TO REASONABLY CONFIRM STAULO'S IDENTITY, HE WAS SUBSEQUENTLY PLACED UNDER ARREST. IT SHOULD BE NOTED THAT STAULO ALSO REFUSED TO EXIT THE VEHICLE DURING THE STOP. USING PROCEDURAL CONTACT STAULO WAS ESCORTED OUT OF THE VEHICLE AND SECURED IN HANDCUFFS, DOUBLE-LOCKED SECURED BEHIND HIS BACK. A SEARCH OF STAULO ON SCENE WAS NEGATIVE FOR ANY WEAPONS OR CONTRABAND. STAULO'S VEHICLE WAS LEFT WITH ITS WINDOWS DOWN AND UNSECURED. STAULO ADAMANTLY REFUSED OFFICERS SECURING THE VEHICLE AND DEMANDED IT BE LEFT IN THE CONDITION IN WHICH IT...

STAULO WAS SECURED IN SAPD VEHICLE 404 FOR TRANSPORT BACK TO POLICE HEADQUARTERS. A PRE AND POST PRISONER TRANSPORT VEHICLE INSPECTION WAS CONDUCTED WITH NEGATIVE RESULTS. STAULO WAS TRANSPORTED TO POLICE HEADQUARTERS AND SECURED IN THE PROCESSING ROOM UTILIZING HANDCUFFS ON THE LEFT WRIST WITH DOUBLE-LOCKS ENGAGED. UPON SECURING STAULO, ALL FIREARMS WERE SECURED IN THE DEPARTMENT DESIGNATED WEAPONS LOCKERS.

STAULO CONTINUED TO BE UNCOOPERATIVE IN HEADQUARTERS AND FURTHER DELAYED HIS OWN PROCESSING BY FAILING TO PROVIDE OFFICERS WITH HIS IDENTITY. HE REFUSED TO ANSWER ANY QUESTIONS PERTAINING TO HIS PEDIGREE INFORMATION, EVEN THOUGH THOSE QUESTIONS WEREN'T CRIMINAL IN NATURE.

USING THE FIRST AND LAST NAME THAT STAULO GAVE OFFICERS ON THE TRAFFIC STOP A SEARCH OF NJ E-COURTS REVEALED THAT CARTERET PD STOPPED AND ISSUED A PERSON BY THE SAME NAME WITH THE SUFFIX III ON FEBRUARY 27TH 2025. USING A PROCESSING PHOTO, CARTERET POLICE WERE ABLE TO CONFIRM THE SUBJECT WE HAD IN CUSTODY WAS THE SAME OPERATOR FROM THEIR TRAFFIC STOP IN FEBRUARY (IDENTIFIED AS JOSEPH D STAULO III, DOB 08/05/1990). CARTERET POLICE STATED THAT THE OFFICER ON THE MOTOR-VEHICLE STOP IN FEBRUARY WAS ABLE TO CONFIRM IDENTITY THROUGH A PASSPORT CARD.

STAULO WAS PHOTOGRAPHED AND FINGERPRINTED ON HIS CHARGES. STAULO WAS PLACED ON COMPLAINT SUMMONS: 1220 S 2025 000054 CHARGED WITH 2C:29-3B(4).
