On 05/16/23 at approximately 20:53 hrs I was dispatched to Target located at 5000 Hadley Center Drive for a juvenile male in custody for shoplifting.

Upon arrival with my BWC activated I made contact with Loss Prevention Officer Nelson Ortega. Ortega directed me to the Loss Prevention Office where the juvenile male, later identified as [REDACTED], was being held. Ortega stated [REDACTED] and another female, later identified as Lizabeth Montachana-Nata, loaded a shopping cart with items. [REDACTED] then took possession of the cart and walked past all points of sale without paying and exited the store at the Starbucks exit. [REDACTED] was located outside the store by Ortega and brought back inside the store to the Loss Prevention Office where he was held until my arrival. Ortega provided me a receipt of the numerous different apparel, household, beauty, and grocery items which totaled \$827.48. Ortega also provided me security footage of the incident.

Ofc. McCoid was on scene and checked the area for Montachana-Nata. Montachana-Nata was located in the parking lot of Target in a vehicle bearing NJ registration [REDACTED] by Ofc. McCoid. There were 2 young children in the vehicle with Montachana-Nata, later identified as [REDACTED] daughter [REDACTED] and [REDACTED] younger brother, [REDACTED].

[REDACTED] was transported to HQ's in the rear of vehicle #54 where he was processed and fingerprinted. [REDACTED] originally provided me with a false name and date of birth stating his name was [REDACTED] with the DOB of [REDACTED]. [REDACTED] was able to get in contact with his mother Maria Calucho Diaz, where she responded to HQ's and provided a fake permanent resident card for [REDACTED]. See Ofc. Clinedinst supplemental report.

Montachana-Nata was transported to HQ's in the rear of vehicle #52 by Ofc. Clinedinst where she was processed and fingerprinted. [REDACTED] and [REDACTED] were transported to HQ's in vehicle #51 by Ofc. McCoid.

[REDACTED] was released to his mother and she signed the arrest report taking custody [REDACTED] along with the other two juveniles around 00:30 hrs. He was informed he would be getting a summons with a court date by mail.

Montachana-Nata was released on summons # S1222 2023 000159 for 2C:20-11B and 2C:24-9 and given a court date of 06/15/23 at 09:00 hrs at Middlesex County Superior Courthouse.

A property report was completed. The juvenile admission log was completed. VNF's were completed and faxed. The security footage and receipt were entered into evidence utilizing The Beast, labeled AP-1, and place in locker 16.

**Incident Report**



On 02/21/2025 at approximately 18:30 hours I was dispatched to Party City for the report of a shoplifting that occurred earlier in the day at approximately 14:30 hours.

Upon arrival, with my BWC activated, I spoke with reporting party Upendra Shah. Shah played the security footage of the incident and walked me through what happened.

The suspect, a heavier set black female with short hair and glasses wearing gray sweatpants, a red shirt, a black jacket with an image of the cartoon character "Spongebob Squarepants" on the back, and white sneakers can be seen standing at the helium balloon display. The suspect female then selects various balloon packages off the display and walks into aisle 2 with the packages still in hand.

While in aisle #2 her companion, a black female dressed in black clothing, approaches her and they can be seen talking. While the two females are talking the suspect places the balloons she selected inside of her jacket to conceal them. At approximately 14:51 The two females pass all points of sale and walk out of the building. The females enter a black Honda sedan and drive away. I was unable to make out the characters of the registration on the vehicle due to the video quality, only being able to identify it as a NJ registration.

Shah provided me with a receipt totaling the value of the balloons shoplifted. The suspect shoplifted a total of nine balloons, each valued at \$13.99 and totaling at \$125.91. An image of the receipt was added to the report via digital media. I provided Shah with an Axon link to upload the video surveillance footage from the shoplifting via e-mail. The footage has since been uploaded and entered into Beast.

Shah stated that he would be willing to sign complaints should the suspect be identified.
