****#70 INTERNAL EMPLOYEE THEFT INVESTIGATION AT THE WATCHUNG WALMART, TOTAL VALUE \$22,892.10**

ON FRIDAY 10/12/2007 AT APPROX 1708 HOURS, W.P.D. WAS CONTACTED BY WALMART LOSS PREVENTION PERSONNEL IN REGARDS TO AN INTERNAL EMPLOYEE THEFT INVESTIGATION THAT THEY HAD BEEN CONDUCTING. MR RAY VITELLARO OF LOSS PREVENTION EXPLAINED THAT THEY HAD TWO EMPLOYEES IN CUSTODY, ONE FOR AN INDICTABLE AMOUNT, AND THE OTHER ON A DISORDERLY PERSONS OFFENSE.

OFC SMITH RESPONDED TO WALMART AND PLACED EMPLOYEE LASHANDA MITCHELL UNDER ARREST FOR SHOPLIFTING (RECEIVING MERCHANDISE THAT WAS UNDER-RANG BY WANDA HENDRICKS) ON WALMART'S COMPLAINT. MS MITCHELL WAS TRANSPORTED TO W.P.D., HQTS AND PROCESSED. JUDGE SASSO WAS CONTACTED AND BAIL WAS SET AT \$1,500.00 WITH A 10% OPTION. WARRANT #W-2007-000270 WAS PROCESSED, AND MS MITCHELL WAS RELEASED ON \$150.00 BAIL PENDING A WATCHUNG MUNICIPAL COURT DATE.

OFC SMITH AND I THEN RESPONDED TO WALMART FOR THE SECOND EMPLOYEE, MS WANDA HENDRICKS. WE MET WITH MR VITELLARO WHO EXPLAINED HIS INVESTIGATION TO US. MR VITELLARO STATED THAT WALMART LOSS PREVENTION EMPLOYEES HAVE BEEN INVESTIGATING MS HENDRICKS FOR THE PAST FEW MONTHS. LOSS PREVENTION PUT TOGETHER A SPREAD SHEET WHICH DOCUMENTS THE THEFTS ALONG WITH CORRESPONDING VIDEO SURVEILLANCE FOOTAGE FOR EACH INCIDENT. MS HENDRICKS WAS PROCESSING FRAUDULENT RETURNS (AT THE CUSTOMER SERVICE DESK) THEN POKETING THE MONEY. SHE WAS ALSO UNDER-RINGING MERCHANDISE FOR CUSTOMERS. A REGIONAL LOSS PREVENTION OFFICER TOOK A SIGNED WRITTEN STATEMENT FROM MS HENDRICKS WHERE SHE ADMITS HER INVOLVEMENT, AND ESTIMATES THAT SHE STOLE AROUND \$200,000.00. BASED UPON THE VIDEO SURVEILLANCE EVIDENCE, MS HENDRICKS ADMISSION, AND WALMART'S SPREAD SHEET WHICH DOCUMENTS THE THEFTS, MS HENDRICKS WAS PLACED UNDER ARREST FOR INDICTABLE THEFT AND TRANSPORTED TO W.P.D. HQTS (SEE WALMART'S SPREAD SHEET, WRITTEN STATEMENT FOR MORE INFORMATION).

UPON ARRIVAL AT HQTS MS HENDRICKS WAS PROCESSED, THEN TURNED OVER TO DET LYONS AND I FOR INTERVIEWING PURPOSES. DET LYONS READ MS HENDRICKS HER MIRANDA WARNINGS FROM THE W.P.D. FORM. MS HENDRICKS SIGNED OFF ON LINES 1-5 AND IN THE WAIVER PORTION AGREEING TO SPEAK WITH THE POLICE IN REGARDS TO THIS INCIDENT. MS HENDRICKS STATED THAT SOMETIME IN LATE JULY 2007, SHE STARTED COMMITTING THEFTS BY PROCESSING FRAUDULENT RETURNS THEN POKETING THE MONEY. MS HENDRICKS WOULD SCAN THE BAR CODE FROM A RECEIPT, THEN PLACE THE RETURNED MONEY INTO A BAG WHICH SHE WOULD LATER TAKE. MS HENDRICKS WOULD ALSO PROCESS A RETURN WHERE THE CUSTOMER WOULD GET CASH BACK, BUT ALSO LEAVE WITH THE RETURNED MERCHANDISE. SHE DID THIS BECAUSE SHE HAS A CHILD, AND HIT HARD TIMES FINANCIALLY. MS HENDRICKS COMMITTED APPROX 20-25 OF THESE TYPES OF THEFTS POKETING APPROX \$3,000. MS HENDRICKS RECEIVED APPROX \$300.00 A DAY, 3 TIMES A WEEK ON AVERAGE.

SOMETIME THERE AFTER, A CASHIER WHO GOES BY THE NAME "MS MARY", APPROACHED MS HENDRICKS AND TOLD HER THAT SHE KNEW WHAT SHE WAS DOING AND IF MS HENDRICKS DIDN'T HELP HER FRIENDS OUT, SHE WOULD REPORT HER TO LOSS PREVENTION. ON A WEEKLY BASIS "MS MARY" WOULD SEND FRIENDS AND RELATIVES TO MS HENDRICKS REGISTER TO BE UNDER-RUNG. MS MARY INSTRUCTED MS HENDRICKS ONLY TO RING UP THE SMALLER ITEMS, BECAUSE HER FRIENDS COULDN'T AFFORD THE LARGER ONES. THIS PROCESS OCCURRED ALL THE WAY UP TO TODAY'S DATE. MS HENDRICKS DIDN'T RECEIVE ANY BENEFIT FOR UNDER-RINGING MS MARY'S FRIENDS. MS HENDRICKS ESTIMATED THAT THE FRAUDULENT RETURNS AND UNDER-RINGING CAME TO APPROX \$200,000.00. (SEE TAPED STATEMENT TRANSCRIPT FOR DETAILED INFORMATION REGARDING THE INTERVIEW).

I CONTACTED THE SOMERSET COUNTY PROSECUTOR'S OFFICE FOR CASE SCREENING. THE CASE WAS SCREENED BY A.P. LANKFORD WHO AUTHORIZED THE FOLLOWING: THEFT BY DECEPTION 3RD DEGREE, SHOPLIFTING 3RD DEGREE, AND THAT MS HENDRICKS BE RELEASED ROR. MS HENDRICKS SIGNED THE NOTICE OF FIRST APPEARANCE FORM AND WAS RELEASED.

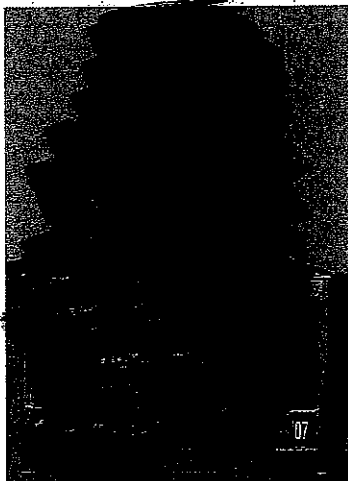

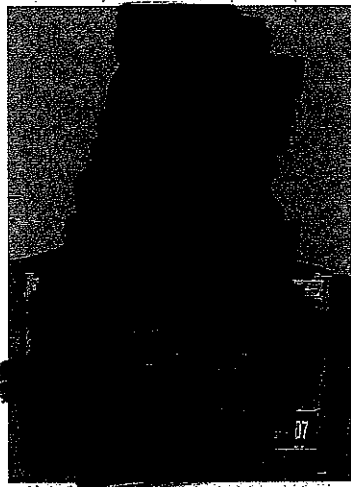
