NARRATIVE [SUSPECT] FRANCISCO, GRISELIBEL - [REDACTED] ON THURSDAY FEBRUARY 5TH, 2015 AT APPROXIMATELY 7:50PM I WAS TRAVELING NORTH ON ROCHELLE AVENUE WITH THE ABOVE VEHICLE IN FRONT OF ME. THE VEHICLE HAD A LICENSE PLATE BRACKET COVERING THE TOP PORTION OF THE "N" IN NEW AND THE "J" IN JERSEY. AS THE VEHICLE MADE A LEFT TURN FROM ROCHELLE AVENUE TO PLAZA WAY THERE WAS NO LEFT DIRECTIONAL THAT ILLUMINATED. WHILE THE VEHICLE WAS TRAVELING WEST ON PLAZA WAY BOTH THE DRIVER AND PASSENGER APPEARED TO NOT BE WEARING A SEATBELT. I COULD SEE THE SEATBELT LATCH ON THE B-PILLARS ON THE DRIVER AND PASSENGER SIDE. A DMV INQUIRY IN VEHICLE 9'S INFOCOP REVEALED THE REGISTERED OWNER HAD NUMEROUS OUTSTANDING WARRANTS FROM LODI. THE VEHICLE MADE A RIGHT TURN ONTO RING ROAD AND USED ITS DIRECTIONAL. A MV STOP WAS MADE ON RING ROAD NEAR BEST BUY. I SPOKE TO THE DRIVER OF THE VEHICLE AND ASKED FOR HIS INFORMATION. BOTH DRIVER AND PASSENGER WERE NOT WEARING SEATBELTS. THE PASSENGER KEPT INTERRUPTING ASKING "WHAT HAPPENED?" I ASKED THE DRIVER IF HE HAD UNPAID TICKETS IN LODI. HE STATED HE DID HOWEVER HE NEEDED TO CONTACT LODI FOR A NEW COURT DATE. THE PASSENGER WAS LEANING OVER THE DRIVER AND ASKING FOR CLARIFICATION ON THE TICKETS. SHE WAS TOLD TO RELAX AND BE QUIET SO THAT I CAN SPEAK TO THE DRIVER IDENTIFIED AS DANIEL FIGUEROA. MR. FIGUEROA WAS EXPLAINED MY COMPUTER WAS SHOWING 3 TRAFFIC WARRANTS. HE WAS ADVISED I WOULD CONFIRM THE WARRANTS WITH LODI. I ASKED THE PASSENGER IF SHE HAD IDENTIFICATION ON HER FOR THE POSSIBILITY OF ISSUING HER A SUMMONS FOR THE SEATBELT VIOLATION. SHE RESPONDED WITH "NO I DON'T DRIVE." I WENT BACK TO MY VEHICLE TO AWAIT BACKUP AND HAVE DISPATCH CONFIRM THE WARRANTS. WARRANTS E14-11316, E14-11317, AND E14-11319 WERE CONFIRMED FOR FAILURE TO APPEAR; TOTAL BAIL AMOUNT \$254.00. I RESPONDED BACK TO THE VEHICLE AND SPOKE TO MR. FIGUEROA. HE WAS ADVISED OF THE BAIL AND HE STATED HE HAD \$100.00 IN HIS WALLET. HE STATED HIS GIRLFRIEND (THE PASSENGER LATER IDENTIFIED AS GRISELIBEL FRANCISCO) CAN RETRIEVE THE REST FROM THE ATM. SHE ATTEMPTED TO EXIT...

NARRATIVE

THE VEHICLE. I WALKED OVER TO THE PASSENGER SIDE OF THE VEHICLE. PO LABOY ARRIVED AS BACKUP. BEFORE HER DEPARTING TO THE ATM I WANTED TO OBTAIN IDENTIFICATION. I ASKED HER AGAIN FOR IDENTIFICATION AND SHE STATED SHE DIDN'T HAVE ANY. SHE WAS HOLDING A BLACK PURSE. I ASKED HER IF SHE HAD ANYTHING WITH HER NAME ON IT IN THE PURSE AND SHE STATED NO BUT SHE WILL CHECK. SHE WENT BACK INTO THE PASSENGER SEAT AND CLOSED THE DOOR. I ASKED HER TO OPEN THE DOOR AND SHE STATED "NO ITS COLD." SHE SEEMED TO BE REACHING ON THE SIDE OF THE SEAT BETWEEN THE PASSENGER SIDE DOOR AND THE SEAT. I OPENED THE DOOR AND SHE BEGAN YELLING AT ME. ON THE FLOORBOARD I COULD SEE A PENNSYLVANIA DRIVERS LICENSE. I COULD CLEARLY SEE HER PICTURE ON THE LICENSE. IT WAS IN MY OPINION SHE WAS ATTEMPTING TO CONCEAL HER IDENTITY FOR AN UNKNOWN REASON. I TOLD HER TO EXIT THE VEHICLE AND SHE STATED NO. SHE BEGAN SCREAMING AT ME TO CLOSE THE DOOR. SHE RETREATED BACK AND WAS SITTING ON THE CENTER CONSOLE SCREAMING AT ME. SHE WAS TOLD TO EXIT THE VEHICLE NUMEROUS TIMES. OFFICER LABOY WAS TALKING TO HER IN SPANISH AS WELL. MR. FIGUEROA WAS TELLING HER TO CALM DOWN AND FOLLOW OUR DIRECTIONS. AFTER NUMEROUS COMMANDS TO EXIT THE VEHICLE. SHE WAS PULLED OUT OF THE VEHICLE BY MYSELF AND OFFICER LABOY. WHEN WE GRABBED HER JACKET SHE WAS PUNCHING OUR HANDS. OUTSIDE THE VEHICLE SHE WAS STILL RESISTING AND SCREAMING. SHE WAS USING HER WEIGHT TO PUSH BACK AND FORTH TO FREE HERSELF FROM OFFICER LABOY AND I. DURING THE STRUGGLE I FELT PAIN IN MY RIGHT MIDDLE FINGER AND RING FINGER. SHE WAS BROUGHT TO THE GROUND AND ULTIMATELY HANDCUFFED BY OFFICER LABOY, OFFICER SHATKIN, AND I. SHE WOULD NOT GET UP OFF THE GROUND. SHE HAD TO BE PICKED UP AND PLACED IN THE REAR OF CAR 6.

WHILE SPEAKING TO MR. FIGUEROA I COULD HEAR A BANGING FROM CAR 6. MS. FRANCISCO WAS ATTEMPTING TO KICK OUT THE REAR WINDOW. OFFICER PINTO ARRIVED AS BACKUP. THE REAR WINDOWS WERE LOWERED TO PREVENT HER FROM KICKING OUT THE WINDOWS. SHE WAS STILL SCREAMING AND BEGAN BANGING HER HEAD ON THE SIDE OF THE DOOR. OFFICER PINTO ASKED HER IF SHE NEEDED TO GO TO THE HOSPITAL AND SHE STATED NO. MR. FIGUEROA WAS HANDCUFFED AND PLACED IN THE REAR OF CAR 9. BOTH WERE TRANSPORTED TO HQ. MR. FIGUEROA HAD A RELATIVE RESPOND TO HQ TO POST BAIL. HE WAS GIVEN A RECEIPT BY PO PINTO, 3 SUMMONSES AND RELEASED.

MS. FRANCISCO WAS FINGERPRINTED AND PHOTOGRAPHED AND CHARGED ACCORDINGLY ON A SUMMONS. SHE WAS RELEASED AND CALLED FOR A RIDE FROM THE LOBBY.
