On the above date and time I, PTL. Roemmele, was dispatched to police headquarters for a walk-in report. Upon my arrival I spoke to Jessica Harrison about an incident that occurred on Saturday, July 25th, 2026.

Jessica stated that sometime in the morning on Saturday that her daughter [REDACTED] and her siblings were at their fathers (Gregory Harrison) house located at 335 Monmouth Road. While there, Gregory and his daughter were involved in a dispute about a watch that [REDACTED] uses to communicate with her mother and friends. According to Jessica, Gregory did not want [REDACTED] to wear the watch and took it off the charger to hide from her. When they went to leave the house, [REDACTED] asked for the watch and Gregory told her she could not have it. When they returned to the house, [REDACTED] asked for the watch again. This time Gregory told [REDACTED] that she could have it but only for a short period of time. When they were going to leave again, Gregory asked for the watch back. At that time, [REDACTED] said no because she wanted to keep her watch. Gregory then [REDACTED]

[REDACTED] Gregory [REDACTED] and she ran to her room. [REDACTED] called her mother and told her what had happened. Jessica stated that she wanted this incident documented due to the ongoing divorce between her and Gregory. Jessica stated [REDACTED] was not injured during the incident [REDACTED]. I did not observe any visible signs of injury. I advised Jessica I would document the incident for her. I also advised to call 911 if something similar was to happen again so that we can send an officer to the scene and rectify the situation sooner. I provided the police case number so she may retrieve a copy of the report as requested. Nothing further to report.
