Incident Report



On the above date and time, I, Ptlm. Brian Lolli #99 of the Wildwood Police Department Uniformed Patrol Division responded to headquarters for a walk in complaint. Upon arrival, I spoke to a female identified as Danielle Wolf who stated that she engaged into an argument with her sister in law Victoria Keoughan. Wolf stated that she was at Keoughan's residence at [REDACTED] Avenue when the incident happened at approximately 0700 hours on October 20, 2022.

Wolf stated that the argument became physical with pushing and shoving but there was no punches thrown. Wolf stated that she wanted the incident documented. I then contacted Keoughan who stated that Wolf was in there residence when an argument began. Keoughan stated that Wolf attempted to strike her with a closed fist but missed and then began to push and shove Keoughan during the argument. At this time, Keoughan stated that she advised Wolf to leave.

Keoughan stated that going forward she did not want Wolf at her residence and stated that she was not welcome at the residence any longer. Wolf was advised of this and was also advised that if she was to return to the residence she would charged with trespassing. Wolf stated that she understood and would not go to the residence anymore.
