On the above date & time I Detective Leicht #296 met with Kyra Kozemko DOB ([REDACTED] 2000). Kyra stated she had concerns about her son [REDACTED] DOB ([REDACTED] 2021) and an incident that she believed happened at the New Egypt Primary School located at 131 Evergreen Rd. New Egypt, NJ, 08533 on Thursday, June 4th, 2026. Kyra stated she gives her son a bath daily and while bathing him Thursday evening she noticed he had marks and bruises located on his right shoulder, left leg, and right tricep. It should be noted these marks appeared to be new, and Kyra stated this was the first time observing these marks on [REDACTED]. Kyra stated her son is [REDACTED]. Kyra added [REDACTED] was pacing around the house stating "teachers are nice" and was getting flustered when she attempted to ask him questions about the marks and school. Kyra reached out to [REDACTED] primary teacher Mts. Cuff attempting to obtain more information. Kyra then proceeded to go to the Primary School Friday, June, 5th, 2026 to set up a meeting. Kyra met with the school, and during the meeting her son [REDACTED] spelt a teachers name "CIL". Kyra believes there is a substitute teacher with the last name Sal. Ptl. Goldfluss #290 is going to be obtaining a list of teachers that were with [REDACTED] on Thursday. Ptl. Goldfluss obtained a list of the aids & substitutes that were in [REDACTED] class the week of the incident, that list has been attached to this report.

At 14:05 I Detective Leicht #296 met with Januari Jones at Plumsted Police Headquarters. Jones wanted to make a statement of her experience earlier this year subbing in Mrs. Cuff's classroom. Jones doesn't recall the exact date she subbed at the Primary School but believed it was a Friday towards the end of April or beginning of May. Jones stated she was in the class with Mrs. Cuff and another male substitute who was tall and had long hair. Jones shift was from 08:40-12:30. Jones stated she witnessed Mrs. Cuff handle one child [REDACTED] very aggressively, and yelled at him for about 2 hours. Jones added Mrs. Cuff picked up [REDACTED] and slammed him on top of a huge beanbag. Jones stated [REDACTED] head slammed back and his tantrum got worse. Attached to this report is the written statement provided by Jones.

While investigating this incident it was later found out on Wednesday, June 3rd, 2026 when [REDACTED] arrived at school while taking [REDACTED] backpack off Mrs. Cuff observed bruises on his shoulder and immediately brought him to the school nurse. When she pointed to the bruises [REDACTED] said "dog" indicating a dog caused the markings. The school nurse reached out to Kyra on Wednesday. At this time this investigation will be closed pending further information. Please see Ptl. Goldfluss's supplementary report for more information.

Attached to this report are the marks on [REDACTED] body, the Facebook post, and RING video footage inside Kyra's residence of the conversation between her and [REDACTED].

Walk in/Officer Request

On the above date and time, I Ptl. Goldfluss #290 was working my SRO assignment for the school district, when I was informed of a Facebook post originating from "New Egypt Happenings" Facebook page. The post specifically is an allegation of abuse occurring at the New Egypt Primary School. While I was at police headquarters, Ptl. Leicht #296 advised me he was speaking with a parent about this post. I joined the conversation with him and Kyra Kozemko. Please see Ptl. Leicht's report for more information.

After concluding the conversation with them I responded over to the primary school (131 Evergreen Rd) and spoke with Mr. Ytreboe and Ms. Drucker about getting information regarding pedigree information for teachers in the room "Y/Z" as well as getting scheduling information for who present in the room with the student. I was able to obtain these records through the law enforcement unit created by the MOA. All information obtained was provided to Ptl. Leicht.

I was also advised during this time the school will be making a notification to DCP&P regarding this incident. A short time later in the day I was advised by Ms. Drucker, that DCP&P will be responding within 24 hours.

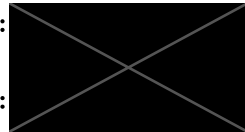
