Incident Report

While patrolling on 11/22/2025, at approximately 0132 hours, I observed a black 2005 Honda Accord bearing New Jersey registration: W11WEF, traveling north on Tenth Street, between Union Avenue and Main Avenue. I observed a broken rear license plate lamp along with a broken rear high-mounted center brake light, both in violation of 39:3-66 (maintenance of lamps). I also observed dark tinted windows on the front windows in violation of 39:3-74 (obstruction of windshield for vision).

I conducted a motor vehicle stop in front of 115 Seventh Street. The operator of the motor vehicle, identified as Mr. Jachai Rice, parked the motor vehicle in the driveway of 115 Seventh Street. Mr. Rice provided me with the vehicle registration and proof of insurance but informed me that he did not have a driver's license. Mr. Rice then provided me with his pedigree information. I advised Mr. Rice that he was stopped in violation of 39:3-66 and 39:3-74. Ptl. Roncaioli arrived on scene.

A Department of Motor Vehicle (DMV) inquiry showed a National Crime Information Center (NCIC) wanted person hit for Mr. Rice out of Passaic County Sheriff's Department (PCSD). Lt. Mueller confirmed the NCIC hit and contacted PCSD. PCSD forwarded us a copy of the child support bench warrant for failure to appear (see attached). An NCIC locate was sent to PCSD.

Mr. Rice was placed under arrest for the child support bench warrant. Mr. Rice was handcuffed and searched incident to arrest, yielding negative results of any weapons and/or contraband. Mr. Rice was secured in patrol vehicle #38 and transported to police headquarters.

Upon our arrival at headquarters, Mr. Rice was secured in the holding cell. A short time later, Mr. Rice was removed from the holding cell and placed on the holding bench outside of the patrol room. Mr. Rice was removed from the holding cell due to a clogged toilet, which caused the toilet to overflow.

Mr. Rice was issued summonses: E25-006134 (39:3-66), E25-006135 (39:3-74), E25-006136 (39:3-40), and E25-006137 (39:3-10) and advised of his court date/time. Mr. Rice along with his paperwork was turned over to the PCSD. Cpl. Destefano #492 and SO Emmolo #1440 took custody of Mr. Rice without incident. No further police action taken.
