Incident Report



On August 16th, 2025, at approximately 1052 hours, P/O Torsiello and I were detailed to 115 7th Street for a report of a DOA.

Upon arrival, we activated our body worn cameras and met with Ms. [REDACTED] and Ms. [REDACTED] at the front door of the residence. Ms. [REDACTED] and Ms. [REDACTED] escorted us to the second floor bedroom, where we observed Mr. [REDACTED] laying prone on the bedroom floor directly next to his bed. Mr. [REDACTED] had no presence of a pulse and was cold to the touch. We observed body to have rigor mortis, along with Mr. [REDACTED] fingertips and toes color purple. Hackensack ALS #103 was dispatched and arrived on scene. ALS contacted Dr. [REDACTED] from Hackensack University Medical Center, who pronounced Mr. [REDACTED] had expired at approximately 1104 hours. While standing in Mr. [REDACTED] bedroom we observed multiple syringes and needles containing heroin scattered through the bedroom. We observed a bag laying on the bedroom floor containing a substance drug. We observed Mr. [REDACTED] mattress to be covered in blood along with his pillows laying on the mattress. On the edge of his mattress we observed a large kitchen knife, however had no blood on the knife.

When asked how they know Mr. [REDACTED] Ms. [REDACTED] and [REDACTED] stated that they live inside the residence and rent bedrooms from [REDACTED] [REDACTED] They stated that there is an understanding that the bedrooms are not to be entered however, when they did not see Mr. [REDACTED] they became concerned so they entered his room to check on him.

Detective/Lieutenant Mueller was notified on our finding and responded to the scene. Detective/Lieutenant Mueller notified BCI and BCPO unit to respond to the scene to investigate the incident. Detective Sergeant John Dilkes #1364 and Detective Caratozzolo #1858 of BCI arrived on scene at approximately 1250 hours.

I began to filled out a Medical Examiner Report (See Attached). I contacted the Medical Examiners office and spoke with M.E. [REDACTED] and advised of our findings. M.E. [REDACTED] arrived on scene and advised me her case number was [REDACTED] [REDACTED] Bergen County Medical Examiner Transporter, Mr. [REDACTED] arrived on scene and took possession of the body.
