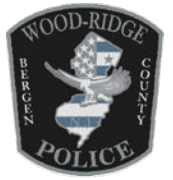

Supplemental Investigation Report



On 08-16-2025 at approximately 1052 hours P.O. Tomat and I were dispatched to 115 7th Street on a report of a possible DOA.

Upon my arrival I was met by two females who explained they were renting rooms at the residence (Ms. [REDACTED] and Ms. [REDACTED]). They stated they had located the victim, [REDACTED] [REDACTED] on the floor of his bedroom laying face down. Ms. [REDACTED] explained she flipped him over and attempted to start CPR on Mr. [REDACTED].

Upon making entry into Mr. [REDACTED] room, I observed the victim lying face down on the East side of his bedroom. He had blackened finger tips, cold to the touch, and rigger had set in. I observed numerous needles on the floor and dressers in the bedroom as well as blood stained sheets and pillow cases. On the edge of the foot of the bed I observed a large kitchen/butcher knife (no blood on knife was observed). Upon a further observation I was able to locate a bag of what appeared to be crack in a zip lock bag on the floor on the West side of the bed.

Upon walking out of the room the adjacent bathroom had syringes as well on the sink.

The scene was turned over to the Detective Lt. Mueller as well as BCI.
