## **Incident Report**



Detailed to [REDACTED] to investigate someone attempting to gain entry into a motor vehicle. Upon my arrival I spoke with the caller, Kimberley Schmidt. She stated that while she was sitting on her front porch, she observed her neighbor approach the rear of her vehicle, [REDACTED] which was parked on the street. She stated that the individual attempted to open the rear hatch on the vehicle, then walked to the driver side door and attempted to open that. She stated the individual then picked up a pile of sticks that were on the ground and threw them on her front lawn. Ms. Schmidt then asked the individual what they were doing and they proceeded to try to open the passenger side door. The individual then walked away, and walked down the sidewalk in an odd manner all the way to the next corner.

The individual then came back and walked into the open garage of their residence, [REDACTED] turned on the light, and proceed to close the garage door.

Ms. Schmidt stated the individual, which was described as an elderly female never entered the vehicle. A check of the CAD for psych issues related to the residence was negative. I attempted to make contact with the resident, Judy Traina with negative results.

No further police presence needed at this time.
